Greer homes to receive free smoke alarms, fire safety information

Greer - The American Red Cross and the Boiling Springs Fire Department visited homes in Greer as part of its Home Fire Preparedness Campaign to teach people how to be prepared for home fires and install free smoke alarms where needed.

The Red Cross conducted a smoke alarm blitz in Greer on July 30th. During the blitz, teams of Red Cross volunteers and local firefighters went door-to-door, meeting with families to test and install smoke alarms, helping them create a home fire escape plan, and discussed the importance of having everyone in the household know what to do in case of a fire.

South Carolina consistently ranks within the top ten states for home fire deaths per capita and in the Upstate the Red Cross assists more than 1,700 people a year after disasters, primarily home fires.

Secretary of State offers free notary public seminars in Spartanburg

Columbia - Secretary of State Mark Hammond is offering six free regional notary public seminars this summer and fall for all South Carolina notaries and those interested in becoming a notary. These sessions offer a reminder that the 2014 legislative session brought many critical improvements to the law regulating South Carolina notaries public. Most sections of the law had not been updated since the 1960s.

Notaries public hold an important position of responsibility. It is critical to understand the duties and responsibilities of notaries under the law. The key function of a notary is to protect citizens against fraudulent activity. Once commissioned as a notary public, it is the responsibility of the notary to maintain a level of training necessary to perform the duties of the position as required by law. These seminars will address state laws governing the duties and responsibilities of notaries. In addition, the seminars will provide information how notaries can avoid pitfalls related to the unauthorized practice of law.

These seminars are a public service of the Secretary of State's Office. Attendees are welcome to attend any of the notary seminars regardless of their county of residence or the location of the seminar.

The Spartanburg County seminar will be held on Tuesday, October 11 at Spartanburg Community College, Tracy J. Gaines Building, G01, 107 Community College Drive in Spartanburg. Doors will open at 5:30 p.m. on the day of the seminar; seminar will begin promptly at 6:00 pm; seminar will conclude by 7:30 p.m.

Joining the comfort animal debate

Facility dogs and comfort items remain credible resources in the courtroom thanks to researchers such as Dr. Dawn McQuiston, Wofford associate professor of psychology.

McQuiston, associate professor of psychology at Wofford College, first learned of the debate over animals in the courtroom when she came across a case in which an attorney's personal use of a therapy dog during trial was challenged on the grounds that it was biasing the jury.

Intrigued, she discovered other instances in which vulnerable witnesses, for example, alleged victims of sexual abuse, needed comfort items to quell anxiety while giving testimony. Again these comfort items were challenged. Defendants appealed their guilty verdicts on the grounds that the items gave victims an unfair edge because they caused the jury to pity them and potentially over believe their side of the argument.

"Every time, the appeals court confirmed the lower court's verdict because it didn't see any bias on the part of the jury, but despite these rulings the issue had never been scientifically tested," says McQuiston, who decided to interview a facility dog handler in Maricopa County, Ariz., and gather more information about their training. "About

half of the states in this country use facility dogs, and all they do is sit quietly by the victim's feet or in their periphery to give them a sense of protection and comfort."

According to McQuiston, the dogs are expertly trained and have an air of professionalism, similar to that of guide dogs.

McQuiston thought it was possible that a trained dog or stuffed animal could evoke undue sympathy among jurors, so she and her students decided to test the hypothesis. They wrote fictional court cases based on real events in which young sexual abuse or robbery victims clutched stuffed animals or facility dogs during their testimony in the courtroom, compared to cases in which the victims did not have access to comfort items. They then examined the verdicts delivered by mock jurors. McQuiston and her team found that comfort items in fact had no impact on jury decisions.

The group also looked at emotional reactions of jurors when a comfort item was present and found that some jurors experienced disgust during the trial, mainly when the witness clutched a teddy bear on the witness stand. McQuiston explains that jurors often experience strong emotional reactions, such as disgust and anger, which can affect their attitudes toward the defendant and, in turn, conviction

rates.

McQuiston's research demonstrates that appeals based on facility dogs in the courtroom are unfounded, and judges no longer must rely on their instincts when weighing questions of fairness when it comes to their presence.

The American Psychology-Law Society published the research McQuiston performed with team members Colin Hayton '16, a Wofford psychology major and philosophy minor from Greensboro, N.C., who will be studying law at Wake Forest University in the fall, and Kayla Burd, a doctoral student at Cornell University focusing on the study of legal decision-making.

McQuiston plans to take the research a step further by interviewing mock jurors to see whether comfort items changed their personal opinions even though they did not change their verdict, and by examining how deliberations affect their views on the use of facility animals. In light of her findings, she also has plans to encourage lawmakers in South Carolina to consider adopting the use of facility animals in the courtroom.

"There are many benefits of having a dog assist children in vulnerable situations," says McQuiston, "and now we have scientific evidence that legal appeals on the grounds that a facility dog is biasing in the courtroom are unfounded."

Belue Farms adds hops to list of S.C.-grown products

Boiling Springs - Over the past 60 years, Belue Farms has grown and sold peaches, berries, melons, vegetables, Black Angus cattle and grain. Now the farm has added a new crop to its South Carolina-grown offerings: hops. Part of the stinging needles plant family, hops are native to Great Britain and primarily grown in the northern temperate zone as well as Australia. Belue Farms' crop is part of a joint venture with Clemson University to evaluate the viability of new crops grown in Upstate S.C.

The hops plant bears flowers that are commonly used as a stabilizing agent and flavoring for beer, and also serve as a medicinal aid to promote sleep, appetite and relaxation. Belue Farm's hops plants are being grown adjacent to its affiliated store, Belue Farms Natural Foods Market on Parris Bridge Road. Considered a bine (or vine), hops grow along a wire or

string to form a teepee shape. As hops need to be pruned or harvested, the wires are lowered for easier access. Planted from rhizomes, hops require at least 120 days before yielding the first harvest. Now in their second year of production, Belue Farms' plants will be harvested July through early September when they die back for winter.

Harriett Belue, co-owner of Belue Farms and manager of

Belue Farms Natural Foods Market, says the farm hopes to sell the crop to both home and commercial brewers. "So far, Hub City Ale House in Spartanburg has purchased our hops to create a new brew called Ferme Ici Saison. The beer will be part of its Ciclops Cyderi & Brewery line and will be a peach wood-smoked farmhouse ale flavored with nectarine, peach, chili pepper."

Belue notes the hops plant's flavor will continue to change for up to nine years. She explains, "Like most plants, the flavor of hops can change based on local soil influences. So some varieties will taste differently when planted in different soils."

In addition to being sold to local breweries, Belue Farm's hops can be purchased in frozen, vacuum-packed bags at Belue Farms Natural Foods Market on 3769 Parris Bridge Road in Boiling Springs. For more information, visit BelueFarms.com.

Why parent-teen communications often fall short

As a parent you want to be there for your teenager. You try to learn what's happening in his or her life and try to help with problems or uncertainties he or she may be facing.

But despite your best efforts, most of the time you are rebuffed. Responses ranging from stony silence to outright hostility leave you wondering how you have failed so miserably in connecting with your own child.

The problem, however, may not be your fault but just the simple fact that parent-teen communications are inherently complicated.

One reason is simply that it's not easy to be a teenager. There's a variety of unsettling biological, psychological and emotional changes that are all part of a teen's normal developmental process. Pile on top of that the pressures of school, extracurricular activities, maybe a part-time job, and then the anxiety of college or a career in the near future, and it becomes easier to understand why the open communication you enjoyed with your pre-teen has become much more challenging.

Teenagers may often feel that their parents just can't understand all the changes and pressures they are facing. These feelings may be reinforced when parents react negatively to teens seeking to separate more from their parents and be more independent.

While we all want our children to grow up and be responsible adults, it can be confusing to deal with as our teens take their first tentative steps in that direction. This same process is also hard on the teen's side. He or she is anxious about sharing feelings of insecurity or uncertainty, about admitting mistakes, since it will just make him or her look weak, immature and not ready for the freedoms so badly desired.

There is no quick fix for any of these communication issues, but it's important not to give up on the effort. While many of your communication attempts will likely seem inadequate, every now and then you will break through and have a meaningful discussion. As importantly, your attempts to stay connected are active demonstrations of your love and concern.

Look for opportunities to let your teens know you're trying to understand and sympathize with all they are facing. Offer positive feedback when it's deserved and let them know your trust and respect is being earned. It takes work to open up communication, but it is worth the effort.

Despite vehicle advances, breakdowns at record high

Charlotte, N.C. – Despite advances in vehicle technology, including maintenance reminders and other dashboard alerts designed to mitigate roadside trouble, AAA Carolinas rescued close to 1 million drivers in 2015. Vehicles fewer than five years old in particular experienced a higher proportion of tire and key-related issues than older vehicles, suggesting that the trend toward eliminating the spare tire and moving to electronic keyless ignitions may have unintended consequences.

“Even though vehicle technologies are more advanced than ever, drivers are still vulnerable to breakdowns,” said President and CEO Dave Parsons, “AAA Carolinas is dedicated to giving our members peace of mind, which is why we helped a

record breaking number of drivers in 2015.”

Owners of new vehicles may be unaware that some new vehicle designs and features may leave them vulnerable at the roadside. To reduce vehicle weight and boost fuel economy, spare tires are being eliminated from new vehicles at alarming rates, and are being replaced with tire inflator kits that can only remedy some flat tire situations. Additionally, new keyless ignition systems can drain the battery life when keys are stored too close to the vehicle and can lock a driver out of the vehicle while the engine is still running. Finally, despite nearly all new vehicles being equipped with low fuel warning alerts and range estimations, a higher proportion of drivers are using these systems to push

the limits between fuel ups.

Other key findings from an analysis of AAA's 2015 roadside assistance data include:

* Battery failures and flat tires vehicle remain the top roadside assistance requests.

* Vehicles fewer than five years old have a higher proportion of tire, key and fuel-related issues than older vehicles. Due in part to complex, electronic vehicle designs, one-in-five service calls for a newer vehicle required a tow to a repair facility.

* Vehicles between 6 and 10 years old have the highest proportion of battery-related issues, as most batteries have a three- to five-year life.

* Drivers are most likely to request roadside assistance on Mondays and least likely to request assistance

on Saturdays.

* Despite advances in key technology, AAA came to the rescue of more than 100,000 drivers locked out of their vehicles.

To help prevent millions of roadside breakdowns from happening, AAA offers the following recommendations for common roadside problems:

* Check for a spare tire: Before purchasing a car, check that the vehicle includes a spare tire. If it doesn't, consider adding one as an option. Tire inflator kits -- which have replaced spare tires on tens of millions of vehicles -- cannot remedy all types of tire damage.

* Check tires: At least once a month, check the tire pressure to ensure proper inflation. This affects tire wear and vehicle handling. Tires should be rotated

based on the manufacturer's recommended schedule for the vehicle.

* Lockouts: AAA recommends motorists take special care of their “smart keys” and keyless entry fobs. Always take keys when exiting the car, avoid exposing keyless-entry remote or smart keys to water and always replace the key or fob battery when recommended by the vehicle manufacturer.

* Battery: AAA recommends that drivers have their vehicle's battery tested when it reaches three years of age and on an annual basis thereafter. AAA's Mobile Battery Service offers free battery testing for AAA members.

* Pack an emergency kit: A recent AAA survey shows that more than 40 percent of motorists do not carry an emergency kit in

their vehicle. AAA recommends that every driver have a well-stocked emergency kit, which includes a mobile phone and car charger; a flashlight with extra batteries; a first-aid kit; drinking water; extra snacks/food for your travelers and any pets; battery booster cables; and emergency flares or reflectors.

- Talk to your kids about what activities they participate in at PE. Is it a diverse range of activities? Activities should include a wide range of skill-building and moderate to vigorous physical activity.

- Supplement physical activity at school with an active lifestyle. What activities can you do as a family? Play sports with kids on weekends, take walks and bike rides and encourage kids to put down the screens and be active at least 60 minutes each day.

Child health advocates say that at a time when more than a third of children and adolescents are overweight or obese, according to the Centers for Disease Control and Prevention, PE needs to be made a priority in schools nationwide.
