OneSpartanburg, Spartanburg County partner to establish Keep S.C. Beautiful affiliate

Aligning with findings from the OneSpartanburg community assessment, OneSpartanburg and the Spartanburg County Environmental Enforcement Department are establishing a Keep South Carolina Beautiful affiliate in Spartanburg.

Keep OneSpartanburg Beautiful will tackle the problem of litter by coordinating volunteer roadside cleanups and promoting anti-litter education across the county. The effort is inspired by the OneSpartanburg community assessment, showing residents believe an improved community appearance increases the health, safety and quality of life, along with the potential for countywide economic growth and development.

Keep OneSpartanburg Beautiful will focus on the beautification and revitalization of corridors countywide and the gateways welcoming visitors, tourists and potential residents to Spartanburg County.

A cleanup day organized by OneSpartanburg in late-October featured volunteers picking up 62 total bags of litter, totaling about 1,550 pounds of trash removed from alongside roadways in Spartanburg and Inman.

The Spartanburg County Environmental Enforcement Department will run the daily operations of Keep OneSpartanburg Beautiful with the Spartanburg Area Chamber of Commerce running the administrative portion of the effort.

Keep OneSpartanburg Beautiful will be a countywide affiliate of Keep SC Beautiful, under the Keep America Beautiful umbrella.

Poliakoff the Mullis Award of Excellence, a top honor recognizing service, commitment and education in the protection and promotion of justice. SCAJ has over 1300 members and is a leading advocate for matters related to an accessible judicial system and fairness under the law. The award was presented during their Annual Advanced Trial Lawyer College in Atlanta, Georgia, where lawyers from around the nation gather for training and education seminars.

Tourism impact tops \$307 million in Spartanburg

Tourists spent more than tourism. Spending by \$278 million in Spartanburg County according to the latest report from Dr. Brookover Bob University, Clemson resulting in a total economic impact of \$307.8 million in fiscal year 2017-18. The Spartanburg Convention & Visitors Bureau commissioned the report to measure the visitor economy.

Spartanburg County was a top-10 visitor destination – just outside the top-5 - inSouth Carolina.

Tourism supported 6,677 jobs in Spartanburg County, according to the latest tourism report, and local government received more than \$17 million in taxes and fees from

tourists in Spartanburg County also generated more than \$55 million in revenue for South Carolina state government enti-

Brookover first measured the impact of tourism in Spartanburg in 2011 as part of the county's Tourism Action Plan and Feasibility Study. The impact of tourism in FY2008-09 was \$193.01 million, which supported 4,187 jobs. The late mayor of Pacolet, Elaine Harris, and former County Councilor Jane Hall spearheaded the effort to provide a tourism development plan. A handful of new hotels opening across the county will enable the CVB to furthering the economic impact tourism has on the

"This report shows that tourism has emerged as an important growth industry in Spartanburg County," said Allen Smith, President and CEO of the Spartanburg Chamber of Commerce. "With at least five new hotels under construction, and dozens of new restaurants opening this year, the visitor economy here is strong and makes Spartanburg County a must-visit destination in South Carolina."







On behalf of basketball player Brian Bowen II, McLeod Law Group and Jason Setchen, PA file federal racketeering lawsuit against Adidas

Charleston - Recently, the McLeod Law Group filed a federal lawsuit on behalf of Brian Bowen II against Adidas America, Inc. and its associates James Gatto, Merl Code, Christian Dawkins, Munish Sood, Thomas Gassnola and Christopher Rivers, alleging violations of the Racketeer Influenced and Corrupt Organizations (RICO) Act.

Brian Bowen II was a McDonald's All-American and consensus five-star basketball player who in June 2017 committed to play at the University of Louisville. Unbeknownst to Brian, he had been targeted by Adidas and its associates as a must-get for Adidas' flagship university. On September 26, 2017, before Brian played his first game for the Cardinals, Adidas' bribery scheme was exposed by the U.S. Department of Justice when it announced criminal charges against Adidas marketing executives and their co-conspira-

Adidas spearheaded this criminal racketeering enterprise to coerce the families of top high school basketball players to attend colleges and universities under contract with Adidas to boost the corporate brand and increase profits in the ultra-competitive \$25 billion athletic shoe market. Once student athletes, such as Brian, commit to an Adidas sponsored university, they are duty bound to wear Adidas gear and allow Adidas to market their image and likeness for corporate profit.

Because of this criminal scheme and through no fault of their own, Brian and other student athletes lost their eligibility to play college basketball at any school, lost their eligibility to receive financial aid necessary to continue their education, and lost the singular opportunity to develop physically and athletically into NBA draft picks at an elite NCAA Division I basketball program.

Upon filing the lawsuit, lead attorney Mullins

McLeod stated: "Adidas has thus far infiltrated college basketball with complete impunity. It is now time for them to answer for what they have done and to suffer the consequences of the stated: "Adidas tional young man who is determined to right this wrong and to do his part to help free other student athletes from corporate corruption that has no place in college basketball."


Attorney Jason A. Setchen of Miami-based

AthleteDefender.com, who represented Brian throughout his proceedings with the University of Louisville and the NCAA, added "I have always felt that Brian was the true victim of everything that transpired with Adidas. Brian

has been severely damaged due to the actions of others and treated unjustly. I am happy that the McLeod Law Group has undertaken the pursuit of justice on behalf of Brian. I look forward to working in conjunction with them to ensure that Brian finally gets his day in court."
