### City Council approves development deal for new westside apartment complex

A new apartment development is coming to the westside after Spartanburg City Council voted unanimously on Monday, February 8th to approve a development agreement with Greystone Property Development III Corp. Located on Franklin Avenue, the parcel became the first property annexed into the city on the western side of Interstate 26 in 2019.

As part of the development agreement, 10 percent of the development's 288 units will be set aside for "workforce housing," meaning the apartments will be leased to tenants whose incomes are at or below 80 percent of Spartanburg's median household income. A one-bedroom unit would lease for a maximum of \$971 per month, with two and three bedroom leasing for \$1,165 and \$1,346 per month respectively. The agreement also includes a tax abatement allowing the developer to pay the city an annual fee in lieu of tax payment of \$125,177 in the first year and scaling up until year 20. Greystone is required to invest more than \$40 million in the project in order to satisfy the agreement.

### Spartanburg District Two names new principal and director of maintenance

On Tuesday evening, February 8th, the Spartanburg District Two Board of Trustees approved the appointment of two new employees.

Dr. Laura Wyatt received approval to be the next principal of Chesnee Middle School. Mr. Rob Hayes, the current CMS principal, has announced his retirement at the end of this school year.

Dr. Wyatt has been part of the CMS Family since 2004. She has served students there as a math/ELA teacher, a math instructional coach, and, since 2015, as an assistant principal.

Additionally, Mr. Paul Hollifield will be joining the D2 Family as the next Director of Maintenance. He will take over for Mr. Keith Holden who plans to retire at the end of this school year.

Mr. Hollifield brings a wealth of experience to the position. He served in a variety of positions with Michelin Tire Corporation, including reliability engineer and maintenance manager. Most recently, he has worked as the director of maintenance for Spartanburg School District 3.

### Yord-In wins Lady Bison Bay Point Classic

Panama City Beach, FL – Due to inclement weather in the Florida panhandle the final round of the Lady Bison Bay Point Classic was canceled, USC Upstate freshman Suvarin Yord-In (Bangkok, Thailand) won the tournament with a total score of 150.

As a whole the Spartans picked-up right where they left off with a top-three finish in the tournament. USC Upstate posted a 319 in the opening round and then shaved 13-strokes off their score in the second round, to card a 306.

The USC Upstate women's golf team will have a little bit of time off before they head to Kiawah Island for the Kiawah Island Invitational on February 28th.

### CCC & HCWP launch the Southern Studies Fellowship in Arts and Letters

Chapman Cultural Center and the Hub City Writers Project have jointly received a \$150,000 grant from the Watson-Brown Foundation for a new, three-year initiative, the Southern Studies Fellowship in Arts and Letters.

This first-of-its-kind program will bring one early-career artist and one early career-writer to Spartanburg, South Carolina, for a nine-month fellowship of research, creativity, teaching, and travel, culminating in a collaborative project informed by the region. The program, which will begin accepting applications this month, will be marketed nationally to artists and writers who are interested in immersing themselves in the culture of the American South.

## Mary Black School of Nursing receives anonymous donation

Gifts come in all shapes and sizes; some even arrive anonymously.

At the start of the year, Shirleatha Lee, dean of the University of South Carolina Upstate's Mary Black School of Nursing, received such a gift – \$5,000 from an anonymous donor.

"We are truly grateful to this individual," Lee said. "These funds will be added to our general nursing fund, which provides great flexibility in assisting students in need on an individualized basis, as many students present with unique situations in which one-time support can make a tremendous impact on their ability to be successful."

"Additionally, during COVID-19, we have been continually faced with unique challenges and have needed to make program adjustments to continue to meet the needs of our students through virtual learning, remote proc-

The donation underscores the impact a gift of any size can have, particularly in challenging times. Due to COVID-19, state

university budgets remain tight and many universities are experiencing significant cuts across the board. But with the help of private funding, USC Upstate can continue to support students.

Benita Hopkins, associate vice chancellor for Development and Alumni Relations, works closely with university deans and donors to secure funding for USC Upstate's greatest needs.

"We depend on donor generosity to strengthen and enhance academic programs at USC Upstate," Hopkins said. "With donor support, we are able to adapt and adjust to the changing world and cater to the unique circumstances of our students. All of us at USC Upstate are grateful to have such a connection and commitment to higher education and we are thankful there are donors in our community that feel the same."

"BMW is proud to contribute to the U.S. balance of trade as we continue to be the leading manufacturer of premium vehicles for the world."

"South Carolina's long, successful partnership with BMW proves that the growth potential in South Carolina is limitless," said Governor Henry McMaster. "As BMW celebrates leading the nation in automotive exports by value for the seventh straight year, we know that with our pro-business climate and elite workforce they have only scratched the surface of what they can achieve in South Carolina."

### Challenging but successful production year

Like all automotive manufacturers, Plant Spartanburg experienced a production interruption due to the coronavirus pandemic. After a five-week non-production period, associates

returned for one shift on May 4. With new health guidelines and procedures in place, production slowly ramped up as the supply chain stabilized and customers returned in the summer. During the last six months of the year, Plant Spartanburg produced nearly 218,000 BMWs, a record for any six-month period in the factory's history. All totaled, the plant produced 361,365 vehicles for the entire year 2020.

The plug-in hybrid electric variants of the plant's two most popular vehicles set production records in 2020. The BMW X3 xDrive30e (22,964 units) and the BMW X5 xDrive45e (24,248 units) achieved all-time highs, in part, because of a 2019 expansion of the battery assembly hall. These 47,212 electrified BMWs made up 13 percent of the plant's total production last year. BMW has assembled batteries for electrified vehicles since 2015, making the BMW Group a pioneer of electromobility in the United States.

BMW Manufacturing currently produces about 1,500 vehicles each day, exporting more than two-thirds of its models to 125 global markets.

## Casseroles are one-dish wonders

I was looking for a baking pan in the back of a cupboard and inadvertently discovered I have quite a collection of casserole dishes. I started thinking about all the casserole recipes I've collected over the years. When I was a newlywed and novice cook almost 46 years ago, preparing a casserole was my "go-to" dinner recipe.

I decided to do some research on the origin of the casserole, and I discovered that casseroles, both the dish and various recipes, have had a long and interesting culinary history.

There's some debate about the origin of the term "casserole" but most culinary historians think it's from the French word for "saucepan." Casseroles come in a variety of styles, but what they all have in common is that they are typically a large, deep dish used both in the oven and as a serving vessel. The Oxford Encyclopedia of Food and Drink in America provides detailed information about casseroles:

"Casserole cookery has been around since prehistoric times, when it was discovered that cooking food slowly in a tightly covered clay vessel softened fibrous meats and blended succulent juices. With the addition or subtractions of leftovers or inexpensive cuts of meat, the casserole is flexible and economical in terms of both ingredients and effort. The classic casserole, a French dish, was originally made with a mound of cooked rice.

"In the 20th century, casseroles took on a distinctive American identity. During the depression of the 1890s, the economic casserole provided a welcome way to stretch meat, fish and poultry. Certain items also were scarce during World War I, and leftovers were turned into casserole meals. The same was true during the Great Depression of the 1930s."

The casseroles we know today became popular in the 1930s during the Great Depression. Typically, casseroles are composed of a meat, starch, creamy sauce (after 1934, it was usually a creamed soup from a can) and a vegetable. Casseroles are an economical, one-pot meal, and can be prepared in advance for breakfast, lunch or dinner. During the 1950s-'70s, casseroles became an easy way for a busy cook, and a modern workforce composed of women, to prepare the family meal ahead of time.

Today, casseroles have been updated to include a variety of ingredients from lobster and tofu to made-from-scratch sauces and locally grown vegetables. The shape, size and construction materials of casserole dishes have also changed over its centuries-old history. However, the purpose of the casserole is still the same, to bring a familiar container of comfort food to the ones we love.

# Around the Upstate

## Despite pandemic, record investment translates to another strong year for Greenville County economic development

Greenville - Despite a brutal pandemic that took thousands of precious lives too soon and wreaked havoc on communities and economies the world over, the people and businesses of Greenville County, South Carolina know this for certain.

Greenville is blessed with a vibrant community and high quality of life, and business the world over recognizes and values it... and wants to be a part of it. Now, with the sun rising on the earliest days of 2021, the Greenville Area Development Corporation announced another record year for economic development.

Assisted by the GADC, some 25 organizations -- domestic and foreign, manufacturing and office, large and small, public and private -- have chosen to locate to or expand in Greenville County, South Carolina during 2020. Combined, the organizations represent a record \$631 million in new capital investment to enhance the tax base plus 1,422 new jobs to keep Greenville's economy humming.

The Greenville Area Development Corporation (GADC), about to enter its twentieth year of service to the community and charged with promoting and enhancing quality of life in Greenville County by facilitating job growth and investment, termed it "arguably one of Greenville County's most rewarding and remarkable years ever in terms of economic development," said Mark Farris, President and CEO of the GADC.

"The year began normally for everyone, and we were bullish on 2020 coming off one of Greenville's best years ever for economic development in 2019," said Mr. Farris. "But when COVID hit in March, all bets were off. As organizations of all types have done, we had to completely rethink how to conduct business to keep the investment and growth pipeline open for Greenville County. I couldn't be prouder of our team, our Board and our Investors

and allies, and the year's results speak for themselves."

Beginning in April, GADC joined with the County, City and Chamber of Commerce in developing the Greater Greenville Pledge to encourage the safe reopening of businesses and actions to stem the virus. In addition, each team member was engaged at the committee level to work with partners and provide reliable information and resources.

"I believe one of our most important and impactful accomplishments was our ability to adapt quickly and add immediate value to local industries and partners by becoming an information resource for companies that were scrambling to deal with the pandemic," Mr. Farris said.

The \$631 million in new capital investment shattered the county's prior annual high investment of \$476 million set in 2014, while the job additions -- despite the impact of the pandemic -- pushed the GADC's cumulative job announcement total over the 30,000 mark during its history -- the equivalent of creating the 13th largest city in the state right here in Greenville County.

"With COVID, we were concerned about a major slowdown, but it's frankly been a rewarding and remarkable year for Greenville County by virtually any metric," said Mr. Farris in announcing the 2020 results. "The record capital investment greatly adds to our community's economic vitality, diversity and tax base. And the announced jobs, with mean wages well above both County and South Carolina averages, portends a bright future for our community. Raising per capita income is always a primary goal in our efforts, and we continue to raise the bar."

"The industries are diverse, with 17 of our newly located or expansion announcements being in our core manufacturing and distribution industries, while 8 others fall into IT,

office, headquarters, or other segments," he added. "That diversity helps to balance and insulate the local economy in challenging times like we have just gone through and provides the community with a varied economy that is robust and multi-faceted. Equally of note is that 15 of the announcements are in the GADC's defined target industries, which indicates that we continue to put the right emphasis and resources against verticals of highest potential."

Another major contributor to the success of the community in 2020 was the announcement or addition of five industrial and one speculative office buildings, adding close to one million square feet of newly marketable space to the community, Mr. Farris noted. The announcement of Fox Hill Business Park in June -- Greenville County's first major new Class A business park in nearly 20 years -- adds significant growth potential for the community and bodes well for future growth.

"Greenville County uses smart, strategic economic development to opens paths for residents to improve their quality of life through meaningful employment, and to help them contribute to the broader community by creating avenues for self-

improvement and financial security," said Willis Meadows, Chairman of Greenville County Council and a member of the GADC Board of Directors.

"These results show that we are building on the depth and breadth of a solid foundation and that the future here looks bright indeed." Mr. Farris expressed satisfaction that of the 25 announcements, 17 were expansions by existing industry in their local operations, while 8 were organ-

izations making their entrance into the booming community.

"We can be confident that our community is doing the right things when we find existing industry deciding to invest limited and precious resources in expanding here in Greenville County," said Mr. Farris. "The decision on where to place those investments and where to expand is incredibly competitive nationally and globally, and there is no stronger endorsement of a community being business friendly than winning more than our fair share of such expansions right here in Greenville."

Mr. Farris also saluted the community's ongoing commitment to nurturing start-ups and the entrepreneurial ecosystem, expanding emphasis on STEM education, and noted Greenville County continues to attract widespread attention for its smart growth, productive workforce and its affordability.

"It takes support and leadership from many parties -- Greenville County Council and the county's tremendous staff, the cities and municipalities we

work with, and the many members of the GADC Investor base and private sector who play key roles -- to produce these results," he noted.

He also stressed the importance of securing \$1.2 million in grant funds to help facilitate positive decisions on the 25 projects announced in 2020. Those grants, from such organizations as the SC Department of Commerce, the State of South Carolina, Duke Energy and Piedmont Natural Gas are used to mitigate costs in such areas as infrastructure development, site preparation and engineering, and often are critical to final decisions being made in favor of Greenville County over other competing communities.

Since its founding in mid-2001, the GADC team's efforts have resulted in the announcement of more than 30,000 new jobs and in excess of \$5.9 billion in capital investment in Greenville County. # Why getting tech savvy doesn't have to be hard

(StatePoint) More than 12 million people are currently employed in tech-related occupations in the U.S., either as information technology (IT) professionals or employees of technology companies. Yet employer demand for tech workers is still strong in many markets and industries, including technology, financial services, manufacturing, retail, health-care, government and education.

Unfortunately, misperceptions about tech occupations persist. People assume that in such jobs, you're relegated to working alone writing software code or that you need to be a math genius or have an advanced academic degree to even get your foot in the door. These misperceptions can discourage qualified candidates from exploring career options in the IT field.

"Today's IT professional plays a leading role in virtually every business and industry, identifying innovation and technologies that can determine the future of an organization," says John McGlinchey, executive vice president for global certification



with CompTIA, a nonprofit association for the IT industry. "Companies are eager to hire people who communicate effectively, are comfortable working as part of a team and are creative in identifying how to use technology to make a business more efficient and profitable."

In fact, 62% of executives surveyed for CompTIA's "Workforce and Learning Trends 2020" report ranked soft

skills such as relationship building, persuasion, integrity and confidence with equal importance to hard technical skills when it came to hiring for their tech workforce.

For anyone thinking about a career in tech, the best first step is to learn more about the technologies of today and tomorrow, and the occupations associated with these innovations. Many free resources are available.

Here are three examples:

The Future of Tech ([www.futureoftech.org](http://www.futureoftech.org)) is a growing library of resources on what's new and what's next in the world of technology. Topics such as artificial intelligence, augmented and virtual reality, big data and the internet of things are highlighted on the site, which is designed for anyone interested in learning more about technologies that are shaping the way

we live and work.

The IT Career Roadmap ([www.comptia.org/content/it-careers-path-roadmap](http://www.comptia.org/content/it-careers-path-roadmap)) offers insights into a variety of career paths, including tech support, networking, cybersecurity, data and software and web development.

The IT Salary Calculator (<https://www.comptia.org/content/it-salary-calculator>) allows you to explore salary estimates for different tech occupations at dif-

ferent levels of expertise. The calculator includes salary data from 400 different metropolitan areas covering 85% of the U.S. population, from an IT support specialist in Portland, Maine (\$52,750) to a cybersecurity analyst in Portland, Ore. (\$101,530).

"If you don't believe technology is a viable career choice, consider all of the things you've done today that are made possible by technology -- from the car you drive and the streaming entertainment channels you enjoy to a telehealth visit with your doctor and the ease and efficiency of online banking," says McGlinchey.

The IT field is no longer a world of pocket protectors and motherboards. With more people using more devices than ever before to stay connected to one another, industry experts say that today's IT workforce is open for business for anyone with great curiosity, creativity, personality and versatility.

THE HISTORY CHANNEL

- On March 5, 1770, a mob of American colonists gathers at the Customs House in Boston and begins taunting the British soldiers guarding the building. The protesters, who called themselves Patriots, were protesting the occupation of their city by British troops.
- On March 3, 1865, President Abraham Lincoln signs a bill creating the Freedman's Bureau. The federal agency oversaw the transition of African Americans from slavery to freedom. The bureau was given power to dispense relief in the South, provide medical care and education, and redistribute "abandoned" lands to former slaves.
- On March 2, 1904, Theodor Geisel, better known as Dr. Seuss, the author and illustrator of such beloved children's books as "The Cat in the Hat," is born in Springfield, Massachusetts. Geisel used his middle name (which was also his mother's maiden name) as his pen name.
- On March 4, 1918, the first cases of the deadly Spanish flu pandemic are reported in soldiers at Fort Riley, Kansas. The virus soon traveled to Europe with U.S. soldiers heading to aid the Allies in France. The flu would eventually kill 20 million to 50 million people around the world.
- On March 7, 1923, The New Republic publishes Robert Frost's poem "Stopping by Woods on a Snowy Evening," which begins with the famous line "Whose woods these are, I think I know."
- On March 1, 1966, Venera 3, an unmanned Soviet probe launched from Kazakhstan, collides with Venus, the second planet from the sun. It was the first spacecraft to reach the surface of another planet.
- On March 6, 2001, Napster begins complying with a federal court order to block the transfer of copyrighted songs over its peer-to-peer network. Some 60 million users around the world had freely exchanged digital mp3 files using Napster, which folded three months later.

**Internet Access for Veterans**

Fifteen percent of veterans do not have an internet connection, limiting their access to Department of Veterans Affairs video telehealth services. But no longer. The VA's new Digital Divide Consult has geared up to help over 12,000 eligible veterans so far.

If you're a veteran living in a rural area, have limited broadband service, don't have a device with video, have a serious medical condition or are in temporary housing, you can get help with internet access and devices.

But there's more:

If you're part of a HUD-VA program, you can receive a smartphone to reach telehealth.

If you use TracFone SafeLink, T-Mobile (was Sprint) or Verizon, you can hook up with VA Video Connect health care without incurring data charges on your bill. Go to [mobile.va.gov/app/va-video-connect](http://mobile.va.gov/app/va-video-connect) for details. The VA will even do a test call before your visit to check your connection.

If you're in a rural area or don't have broadband at home, the VA has coordinated with various groups and businesses to create locations for you to use for talking privately to your health care providers. The American Legion, VFW and certain Walgreens are part of the Accessing Telehealth through Local Area Stations (ATLAS) program. Go to [connectedcare.va.gov/partners/atlas](http://connectedcare.va.gov/partners/atlas) for locations near you.

The Microsoft Airband Initiative is charged with creating broadband (high speed) in rural areas. Look at [microsoft.com/corporate-responsibility/airband](http://microsoft.com/corporate-responsibility/airband). (While you're there, check into the Microsoft Software & Systems Academy, 18 weeks of training for high-paying jobs.)

Additionally, you could be eligible for the FCC's Lifeline program, which subsidizes broadband and phone service for low-income veterans and veterans who get the following: Medicaid, SNAP, SSI, pension and survivors benefits, and more. (Jury Trial Demanded)  
The Plaintiffs, by and through their undersigned counsel, will show unto this Honorable Court the following:

**FOR A FIRST CAUSE OF ACTION**  
(Spartanburg Memorial Auditorium)

1. That both Plaintiffs are citizens and residents of North Carolina.

2. That Defendant (hereinafter "the Auditorium") is a corporation organized and existing in the State of South Carolina and is located in the City of Spartanburg, South Carolina and the incident addressed herein did occur in the City of Spartanburg and is subject to the jurisdiction of this Court.

3. That on or about March 24, 2018, Plaintiff Tristan Galloway (hereinafter "Ms. Galloway") was an invitee at the Auditorium. Ms. Galloway paid fees that were given to the Auditorium for her daughter to compete in a dance competition and watch her daughter compete.

4. That Ms. Galloway was walking down the aisle meant for invitees of the Auditorium to use in order to enter and exit the Auditorium's seating / spectator area when she fell causing substantial bodily injuries to her.

5. That the Auditorium staff turned the lights out where invitees walk and sit during the dance competition. The Auditorium failed to have appropriate lighting along the sides of the aisle or in the floor of the aisle or above the aisle so that people could see where they were walking. The walking area was made completely black by there being no appropriate lighting once the overhead lights in the Auditorium were turned off.

6. That the walking aisle is carpeted and has slopes that must be navigated by those walking in the aisle. It is imperative for there to be lighting in this area to allow invitees to avoid falling over the slopes. The use of slopes combined with no appropriate lighting created a dangerous situation that was hidden from

the invitees and created by the Auditorium.

7. That the Auditorium failed to post signs warning invitees of the dangerous conditions; therefore, the failure to warn combined with the walking aisle having no appropriate lighting and slopes created a dangerous condition where invitees were directed to walk while failing to warn of the dangers.

8. That while Ms. Galloway was on the ground, other invitees were trampling her as they could not see her lying on the ground. Another invitee had to block others to protect her from being more extensively injured. When EMS arrived, the Auditorium still had not turned on the lights and the EMS workers had to use their cell phone lights to see Ms. Galloway.

9. That as a direct and proximate result of the Auditorium creating a dangerous path where invitees were directed to walk and failing to warn of those dangers, Ms. Galloway sustained the following injuries and damages:

- A. Injuries to her body and most specifically to her lower extremities;
- B. Injuries to her psyche;
- C. The need for extensive medical care including surgery, hospital stays, therapy, medications and medical devices;
- D. The need for ongoing medical care;
- E. Extensive pain, mental anguish, stress and discomfort;
- F. Money spent for medical care and treatment;
- G. Loss of income;
- H. Loss of enjoyment of life;
- I. Future pain, mental anguish, stress and discomfort; and
- J. Future medical treatment and future medical bills.

10. That the injuries and damages sustained by Ms. Galloway were directly and proximately caused by the Auditorium creating a dangerous condition and hiding it and they were negligent, careless, grossly negligent, willful, wanton and reckless in one or more of the following particulars:

- A. In creating a dangerous condition of inadequate lighting;

- C. In failing to warn of the dangerous condition of inadequate lighting and elevation

The Plaintiffs hereby reserve the right to amend these pleadings to add SSS, Inc. should the discovery process reveal that there is such a company involved in this lawsuit.

22. That as a direct and proximate result of Stagehand creating a dangerous path where invitees were directed to walk and failing to warn of those dangers, Ms. Galloway sustained the following injuries and damages:

A. Injuries to her body and most specifically to her lower extremities;

C. The need for extensive medical care including surgery, hospital stays, therapy, medications and medical devices;

D. The need for ongoing medical care;

E. Extensive pain, mental anguish, stress and discomfort;

28. One of the services the personnel provided by Event Partners to the Auditorium were tasked with was ensuring the safe ingress and egress of the Auditorium of those attending the dance competition at issue.

B. Injuries to her psyche;

C. The need for extensive medical care including surgery, hospital stays, therapy, medications and medical devices;

E. Extensive pain, mental anguish, stress and discomfort;

F. Money spent for medical care and treatment;

G. Loss of income;

H. Loss of enjoyment of life;

**FOR A SECOND CAUSE OF ACTION**

(Loss of Consortium)

32. That the Plaintiffs incorporate herein by reference each and every allegation set forth hereinabove as if repeated below verbatim.

33. That as a result of the injuries suffered by Ms. Galloway, her husband, Eric Galloway, was deprived of the society, companionship, consortium, and services of his wife for a period of time.

34. Accordingly, Plaintiff Eric Galloway has been damaged and believes that he is enti-

tled to judgment against each of the defendants jointly and severally for compensatory and punitive damages in regard to his loss of consortium claim in such amount as determined appropriate by a jury at the trial of this case.

WHEREFORE, the Plaintiffs prays for judgment against the Defendants jointly and severally for damages in amounts to be deemed appropriate by the Court at the trial of this case and for such other and further relief as the Court may deem just and proper.
