## AROUND TOWN

### Spartanburg City Council approves first reading of ordinance allowing limited digital signage

During the December meeting, City Council voted 6-1 to allow limited use of LED digital for city businesses and institutions. Council member Erica Brown voted against the measure. Under the new rules, only "monument" signs no taller than 6 ft. would be allowed to contain digital signage, and no more than 30 percent of a sign could feature lighted digital messaging. Other requirements include:

- Messages must remain static for 15 seconds
- Signs which incorporate electronic message boards must have an element of landscaping at the base of the sign included as part of the sign permit package and installation;
- The sign may not display messages from 10 p.m. to 6 a.m.
- An electronic message board sign illumination shall not exceed 0.3 foot-candles over ambient lighting condition
- In order to minimize light trespass on abutting and nearby residential property, illumination measured at the nearest residential structure or rear yard setback line shall not exceed the moon's potential ambient illumination of 0.1 foot-candle;
- The leading edge of the sign shall be a minimum of 100' from any single-family residential property line

### Upstate man pleads guilty to possession with the intent to distribute

Columbia - United States Attorney Beth Drake stated today that Cornelius C. Crawford, age 31, of Union, pled guilty in federal court in Anderson, to possession with the intent to distribute cocaine. United States District Judge Timothy M. Cain, of Anderson, accepted the plea and will impose sentence after he has reviewed the presentence report which will be prepared by the U.S. Probation Office.

Evidence presented at the change of plea hearing established that on October 13, 2016, Officer Montjoy with the Jonesville Police Department observed a car failing to maintain lane and a passenger in the car with no seatbelt. Based on these violations, he initiated a traffic stop. When the car stopped, Crawford (who was the passenger) jumped out carrying a green and orange bag and made a run for it. Officer Montjoy chased him. After a chase, Crawford pulled out a .22 caliber Ruger, turned, and pointed it at the officer. Montjoy ordered him over and over to drop the gun and get on the ground. On the tenth or so command, Crawford finally got to the ground, and tried to bury the gun and a bag of cocaine next to him. Once backup arrived, officers placed Crawford under arrest. In the orange bag, the officer located a set of digital scales, five baggies of cocaine, and .22 caliber bullets.

Ms. Drake stated the maximum penalty this defendant can receive is a fine of \$2,000,000 and/or imprisonment for 30 years, six years of supervised release, plus a special assessment of \$100.

The case was investigated by agents of the Jonesville Police Department and the Federal Bureau of Investigation. Assistant United States Attorney Bill Watkins of the Greenville office handled the case.

The Unity Week celebration includes a Unity Walk, a Day of Service, and the annual capstone celebration event on the night of January 15th. The MLK Unity Week is a centerpiece of the City's Be One initiative, which includes a variety of community diversity events throughout the year.

### Walk As One

The City of Spartanburg's Department of Community Services created the Unity Walk in 2002 as a means of highlighting how Spartanburg's diversity and unity make a stronger community. The Unity Walk celebrates and renews a shared sense of belonging in a place that collectively we are proud to call home. All citizens are encouraged to come out and as a city join hands, walk as one, and continue to recognize and celebrate diversity.

This year's walk is Saturday, January 13, at 9 a.m. and will start from Spartanburg County Public Library Headquarters, 151 S. Church Street in Downtown Spartanburg.

## Improving relationships by improving communication skills

When we stop to think about it, we all realize that good communications are vitally important in building strong, positive relationships with others. The problem is that most of us are leading such busy, often stressful lives, that we forget to really think about communicating effectively.

Good communication does require extra focus and effort. It requires understanding how we communicate and having a desire to improve.

One starting point in overcoming communication difficulties is understanding that, in most cases, men and women actually do communicate differently, according to researchers in the field. Compared to women, most men tend to talk less, are reluctant to discuss feelings, are quicker to seek solutions, interrupt more often, and are quicker to withdraw when confronted by the other person.

To improve how you communicate with others, especially with your spouse or other family members in regard to major issues, you need to get past those communication differences. There are various techniques that can help.

Simple things like making eye contact can make a real difference. You also want to use "I" statements, rather than "you" accusations which automatically will put the listener on the defensive.

It's important to avoid words like "always" and "never" since such absolutes are virtually never true. Similarly, name calling, or being critical or sarcastic are all ways that hinder, rather than improve communication.

An essential element in communicating better is to listen better. It's easy to assume you know what the other person is saying and to start formulating your reply before they're done. Instead, what you really want to do is take the time to listen carefully to what's being expressed. It often helps to repeat what you just heard to make sure you really understand what was meant.

Most of us tend to be unaware of our body language or voice tone, but these can communicate a number of messages. When you use a mocking tone, roll your eyes, put your hands on your hips or cross your arms, you're actually sending a negative message. But when you maintain eye contact, keep a positive or at least neutral expression, and really listen, you're giving positive communication a real chance.

Poor communication is one of the major reasons couples facing problems consult with professional counselors. Communicating well in a relationship takes practice and work, but it pays big dividends in the long run.

## Greenville Swamp Rabbits purchased by S.C. Pro Hockey, will stay in Greenville

Greenville – The Greenville Swamp Rabbits, proud ECHL affiliate of the New York Rangers and the AHL's Hartford Wolf Pack, announced on January 3rd that the organization has been purchased by a new multi-member ownership group led by Steve Donner and have taken the controlling interest of the ECHL club. The sale was completed with previous owner Fred Festa's company Chestnut Street Sports, LLC. and has been approved by the ECHL's Board of Governors in a unanimous decision. The new ownership group, South Carolina Pro Hockey, LLC., has also negotiated a contract extension with the Bon Secours Wellness Arena for the next three seasons. "On behalf of the ECHL Board of Governors, I would like to welcome the new ownership group," ECHL Commissioner Brian McKenna said. "We are excited by their plans for the market. We would like to thank Fred for his considerable efforts on behalf of the Swamp Rabbits and the ECHL." In conjunction with the purchase, Donner has taken over operation of the club from President and General Manager Chris Lewis and will locally control the Swamp Rabbits hockey team as President and CEO of the South Carolina based ECHL franchise. As the new President of the club,



Donner has already established a permanent residence in Greenville with his wife and children. "There are a few key messages that we want to send out to the Greenville community," said Donner regarding the organization's future. "First, the team is staying in Greenville. As owners, we believe in the market and are excited to have extended our lease with the arena. Second, as leader of the ownership group, I am immediately taking residence in Greenville. Being a part of the Swamp Rabbits was both a business opportunity and a quality of life opportunity for my family. We are excited to be here and become a part of the Greenville community." "We want to show (Greenville) that we are going to be a relationship organization moving forward," Donner continued. "Fun and entertainment will be a big part of our focus here. We want to be a competitive organization both on and off the ice, striving for championships and surrounding the team with a very entertaining atmosphere in the building." The first item of business by the new ownership group was to extend the team's lease with the Bon Secours Wellness Arena. The two parties have come to an agreement to extend the lease through the 2020-21 season, keeping hockey in The Upstate. The Swamp Rabbits new ownership group is "excited to have worked with Bon Secours Wellness Arena General Manager Beth Paul on adjustments that will benefit both the arena and the Swamp Rabbits organization in building the team's business model

for future success." The new lease also represents a true partnership opportunity between the arena, the team, and The Upstate community. "We are excited to continue our partnership with the Greenville Swamp Rabbits," says General Manager of Bon Secours Wellness Arena, Beth Paul. "We have a strong relationship with the team and look forward to continuing that with the new team ownership. Hockey is a great asset to Greenville and to the arena and we look forward to many more winning seasons with the Swamp Rabbits." "Advancing the lease was ultimately important to us," said Donner. "We didn't buy the team as a relocation opportunity. We bought the team as a great opportunity in Greenville and wanted to make a statement. The best way to

prove that is to commit to a multi-year lease with both the building and the community." Donner is no stranger to success in professional hockey and has over 27 years of experience in professional sports. The Rochester, New York native served as team owner, president and CEO of the AHL's Rochester Americans for 13 years from 1995 to 2008. Donner's early efforts were rewarded in 1996 for his contributions to the league, earning recognition as the most outstanding executive through the James C. Hendy Memorial Award. The Amerks went on to capture the 1997 Calder Cup Championship that season, one of ten championships that Donner has been a part of throughout his career. Prior to his work in Rochester, Donner was the Vice President of Marketing and Sales for the Tampa Bay Lightning during the inaugural season of the NHL franchise. He helped improve the organization and build its average attendance from 10,000 fans in the inaugural season of 1992, to over 22,000 fans in the club's second season. Since his tenure with the Americans, Donner has been a part of multiple ventures in Florida including the start-up of the Orlando City Soccer Club.

# Music Foundation presents two jazz concerts in Hendersonville

Whether you like your jazz straight up or with a twist, there will be jazz aplenty at the Hendersonville Community Theatre Friday and Saturday, Jan. 12 and 13, when the Music Foundation of Western North Carolina (MFWNC) presents "New Orleans Baroque" and "Jazz Standards." Both concerts start at 7 p.m. and benefit the Theatre's building renovations and programming.

On Friday night, the "New Orleans Baroque" concert will be a heady mix of jazz and classical Baroque music performed by flutist Rita Hayes, double bass player Keith Freeburg, drummer Morgen Cobb, and pianist Dr. John Cobb. "This concert will be a unique blending of different music genres," MFWNC founder Joann Freeburg said. "The musicians are a tight group of local performers who have come up with a program of music that will deliver the best of both worlds in some very interesting ways. You'll be surprised at how they have fused American jazz and European Baroque. It's classical music with a jazzy twist."

On Saturday night, the "Jazz Standards" concert will present the music of George Gershwin, Cole Porter, and Irving Berlin. It will be performed by pianist Michael Jefry Stevens and vibraphonist Jason DeCristofaro. "This concert will be for the jazz purists," Freeburg said. "These master musicians will salute the great American jazz composers. You'll be sure to recognize these tunes and appreciate the musicians' dedication to established quality."

Tickets to each concert are \$35 and can be purchased online at HendersonvilleTheatre.org. The theatre is located at 229 S. Washington Street in downtown Hendersonville.

The Music Foundation of Western North Carolina is a non-profit organization dedicated to uniting, promoting, and building the presence of the musical arts in the Carolinas. It was founded by Joann Freeburg.

As the Official Community Theatre of Hendersonville, Hendersonville Community Theatre, Inc. is a non-profit, non-professional, wholly volunteer organization of theater-lovers. Its purpose is to enrich the lives of neighbors by providing high quality productions of excellent theatrical works to the broadest possible audience in Hendersonville, all of Western North Carolina, and Upstate South Carolina. The money raised by these concerts will be used for the building's renovations, windows, and dressing rooms, as well as theatrical programming and arts education initiatives.

Hayes plays flutes, hammered dulcimer, and is a vocalist. She received her bachelor's degree in music from University of Cincinnati College-Conservatory of Music and her master's degree in music from Western Carolina University. She has been a member of the Asheville Symphony for more than 25 years. She serves on the faculty of Brevard College and Asheville Buncombe Technical College in addition to her private student teaching. For nearly 20 years she has hosted classi-

cal music programming on the National Public Radio affiliated Asheville station, WCQS. Performing with such music celebrities as Roberta Flack and Ray Charles has been the highlights of her musical career.

Freeburg is the founder and owner of Freeburg & Perzina Pianos in Hendersonville. Music has been Keith's passion since he learned to play piano, guitar, and string bass as a child. He pursued bass and graduated from the University of Minnesota as a string major with a Bachelor of Science Degree in Music Education. After teaching concert orchestra for several years, he studied piano technology at McPhail School of the Arts in Minneapolis and began a full-time career in piano tuning, repair and rebuilding. For the past 31 years, he has been serving pianists primarily in Western North Carolina and Upstate South Carolina. He is a member of the Asheville Area Piano Forum and performs with the Hendersonville Symphony Orchestra and the Brevard Philharmonic. He serves as an elder and musician at his church. He and his wife Joann Freeburg have two children and three grandchildren.

Cobb is a musician and teacher based out of North Carolina. He is the drummer for McKayla & The Differential and other groups. A native of Bernardsville, NJ, he currently lives in Asheville. "I play the drum set, and various other percussion instruments. Music is my life," he said.

Dr. Cobb is an international performer and recording artist known for his broad interpretive range and technical command. The New York Times has praised his "solid technique, bronze tone and flexibility of interpretive style." The Chicago Daily News commented, "the vibrations that filled the hall were less those of the piano than those of an exquisite musical mind." Dr. Cobb has been presented by Artists International on their Distinguished Artists series in New York City and has made recordings of 20th Century as well as early piano music on original instruments at the Metropolitan Museum of Art in New York. Dr. Cobb has performed internationally some of the most important works of contemporary music and has worked directly with many of the most influential

composers of this era, such as Aaron Copland and Lukas Foss. While completing a Doctor of Music degree at Northwestern University, Dr. Cobb held a fellowship at the University of Chicago, where he pursued doctoral studies in musicology and held the position of staff pianist with Ralph Shapey's Contemporary Chamber Players. He continues to perform a broad repertoire of chamber music and has collaborated with renowned artists such as Joel Smirnoff, former first violinist with the Juilliard String Quartet, and most recently with Jason Posnock, concertmaster of the Asheville Symphony Orchestra. Among Dr. Cobb's orchestral appearances is a performance of the Samuel Barber Piano Concerto with the Asheville Symphony. As a frequent performer on the Piano Forte concert series at the Asheville Art Museum, Dr. Cobb celebrated Franz Liszt's bicentennial with an all-Liszt solo program during the summer of 2011. Dr. Cobb is a direct musical descendant of Liszt through his teacher, pianist Claudio Arrau, whose teacher was a pupil of Liszt. He presents master classes on piano technique and literature, and frequently serves as an adjudicator for competitions and music festivals. Dr. Cobb maintains private studios in Fairview and Hendersonville.

Over the past 40 years pianist/composer Stevens has been associated with some of the most important figures in modern jazz. Beginning with his first CD release in 1991 as a member of Mark Whitecage's Liquid Time Group, Stevens has been in the forefront of the NYC and international improvised music scene. Between 1988 and 1990 he co-lead the now legendary "Mosaic Sextet" with Dave Douglas. This group included Mark Feldman on violin, Michael Rabinowitz on bassoon, and the rhythm section of Harvey Sorgen on drums and Joe Fonda on bass. Their "Today This Moment" CD release on Konnex Records and re-release on GM Recordings is considered one of the classic modern jazz recordings of the 1990s and was voted one of the best 1000 jazz recordings by the 2011 Penguin Guide to Jazz. This rhythm section went on to become the nucleus for the Fonda/Stevens Group. Since the quartet's inception in 1992,

the Fonda/Stevens Group has released 14 CDs, repeatedly toured Europe and is one of the most successful working modern jazz groups on the international scene. Stevens also began a very fruitful and fulfilling relationship with Leo Records with his duo "Haiku" CD release in 1994, featuring Mark Feldman on violin. These piano/violin improvisations proved to be a pivotal

link between Stevens' work in both the composed and improvised music worlds. Stevens has currently released nine CDs on Leo Records, including "Elements" with bassist Dominic Duval, and "Twelve Improvisations" with the Fonda/Stevens Group. To date he has released more than 90 CDs. In 2016 he was voted "Best Composer" in Western North Carolina by

the readers of the Mountain Xpress and received a "Regional Project Artist Grant" from the Toe River Arts Council. He currently resides in Black Mountain, NC.

DeCristofaro is an active musician and composer, performing primarily as a vibraphonist. In 2011, he was selected as the winner of the Yamaha/Percussive Arts Society international competition for jazz vibraphonists, and his musical compositions have been performed in China, New Zealand, Sweden, and throughout the United States. DeCristofaro is currently adjunct music faculty at Warren Wilson College, where he directs the Jazz Ensemble and teaches courses in Jazz Theory and Improvisation, Jazz History, and World Music, and A-B Tech, where he teaches Jazz History and Music Appreciation. He also teaches Jazz Theory and Improvisation, Percussion, Piano, Composition, and Music Theory privately at Crushed Leaf Studios in Mills River, NC. Since 2012, Jason has been the musical director and host of Jazz Night at the Phoenix, a weekly showcase at the Phoenix in downtown Brevard.

# Upstate recognizes three December student-athlete graduates

USC Upstate athletics celebrates three current student-athletes who have completed their eligibility as a Spartan and have earned their degrees as the university held its December graduation ceremony on Tuesday, December 19th at the Spartanburg Memorial Auditorium.

The three student-athletes that earned their degrees this semester were Tori Brown (women's soccer), Jade Hudson (women's soccer) and Kyle Juell (men's soccer).

Upstate has continued to excel in the classroom heading into the 2017-18 academic year by having over 140 student-athletes last year earn recognition on the ASUN Academic Roll for the fourth time in ten years in the ASUN. In total, the Spartans placed 64.23 percent of their student-athletes on the team.

"Each of these student-athletes have taken a different path leading up to graduation, but I am glad they are walking away with a meaningful degree and the preparedness to be successful in their careers," said Susan Kolb, Academic Advisor for Student

Athletes. "I am very proud of these three student-athletes and I am excited to see where their future takes them."

Brown transferred to Upstate from nearby Spartanburg Methodist College and played two

seasons on the women's soccer team. An interdisciplinary studies major, Brown turned in the best year of her career as a Spartan in 2017 playing in 17 games with 14 starts as a defender. A native of Boiling Springs, Brown

dished out one assist this season at Jacksonville. Last season, Brown logged action in 11 games and registered eight starts.

Hudson is a native of St. Leonard, Md. and was on the women's soccer team from 2013-17. A graduate

of USC Upstate's historic Mary Black School of Nursing, Hudson appeared in 58 career games for the Spartans and recorded 31 starts as a defender. She made seven starts in 2014 and a career-best 17 in 2015 before missing last

year due to injury. This season, Hudson appeared in 14 games with seven starts. After losing three of his closest friends in James Campbell, Mills Sproull and Josh Lee in a car accident back in 2015, Juell was lifted up and inspired by the #SpartanStrong movement around Spartanburg and now exits as a graduate from USC Upstate with a degree in business marketing. The Fort Mill, S.C. native played in a career-high 11 games this past season for the Spartans with three starts at the defender position. After missing all of 2015 with an injury, Juell played in five games last season. He scored one goal as a sophomore in the 2014 season opener against UNC Asheville.

# Hearty food and wine ideas for winter

For an appetizing pairing, consider serving Pinot Noir alongside a classic recipe from the Terrôir Restaurant at Craggy Range Winery: Roast lamb shoulder with salsa verde and roasted carrots. The

wine's bright red fruit will bring out the lamb's darker, earthier notes for a delicious meal.

**Ingredients:**

- 1 boned lamb shoulder, rolled and tied.
- 1 lg. onion (quartered)
- 1 carrot (quartered)
- 4 cups chicken stock

**For the brine:**

- 8 cups of water
- 1/2 cup salt
- 2 tbsp. brown sugar
- 3 bay leaves
- 1/2 onion, sliced
- 1/2 packet pickling spices

**For the Salsa Verde:**

- 1/2 cup Italian parsley
- 1/2 cup mint

- 1/4 cup cornichon pickles
- 2 tbsp. capers
- 1/2 cup olive oil
- 2 lemons - juice and zest

**Brine Instructions:**

- 24 hours in advance: Add all the ingredients into a pot. Bring to a simmer at medium heat until all salt

has dissolved. Allow brine to cool completely. Place the lamb in the cool brine, cover and leave for 24 hours. Drain the brine and pat dry.

**Instructions:**

- Preheat the oven to 300 degrees.
- Preheat a large skillet over medium heat for 3 to 5 minutes. Raise the heat to medium-high and add the lamb. Brown the lamb all over then remove from heat.
- On a roasting tray, add carrot and onion. Then add 4 cups of hot chicken stock.
- Place the lamb on top and then put in the oven to cook for 3 hours.
- Remove lamb from the liquid, rest for 25 minutes. In the meantime, strain and skim the stock and reduce by 2/3rds.
- For the salsa verde, blitz all ingredients in the food processor until smooth.
- Slice the lamb and garnish with roasted baby carrots, salsa verde and some stock. Serve with a glass of Te Muna Road Pinot Noir.

# Peddle power: Research helps answer question about rehab from ACL tears

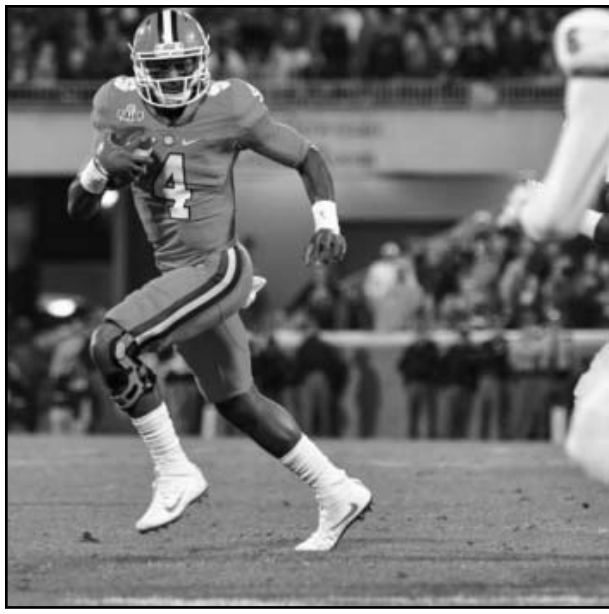

Clemson — Former Clemson quarterback Deshaun Watson famously played in a 2014 game with a torn ACL. This season, he was burning up the NFL record book when the ACL in his other knee snapped, ending his season and breaking the hearts of tens of thousands of fans.

The former Clemson University star has a lot of company on the sideline. As many as 250,000 people each year in the United States get benched by an injury to the anterior cruciate ligament, or ACL.

Despite the prevalence of the injury, there continues to be scientific debate about how to more effectively rehabilitate the knee after reconstructive surgery. As a result, methods and outcomes vary; one-third of people recovering from an ACL tear don't return to sports within a year, and 25 percent who do return will injure their knee a second time.

“Over the course of a year, you may begin to do

more activity on your injured leg, but the question is whether the muscles regain full strength,” says John DesJardins, an associate professor of bioengineering at Clemson.

Researchers at Clemson University, where Watson led the Tigers to the 2016 National Football Championship, and nearby Furman University, have taken a step toward understanding the vulnerable lig-

ament, which acts like a seatbelt for the knee, keeping the lower leg bone from flying through the joint during sudden stops.

Previous research showed that people going through rehabilitation after ACL reconstruction avoid using their quadriceps — the group of muscles in the front of the upper leg that allows the leg to extend. They rely on their hamstrings — the muscles on the back of the

upper leg that allow the leg to flex. As a result, the quads lose strength and the knee takes longer to fully recover.

Therapists often use a stationary bike in ACL rehab programs, but there are different methods. Sometimes the patient peddles with both legs, sometimes they peddle with only the injured leg.

At Furman's Molnar Human Performance Lab,

Randy Hutchison, associate professor of health science, and Clemson's John DesJardins, associate professor of bioengineering, put 17 people through a stationary cycling trial; seven were within a year of ACL reconstruction surgery and 10 had no history of an ACL injury. Their work was published in the *Journal of Functional Morphology and Kinesiology*.

According to the

Clemson-Furman research, people without an ACL injury who peddled a stationary bike with both legs used their quadriceps muscles much more than their hamstrings. But when they peddled with only one leg, the reverse was true — hamstrings took over for the quads.

However, people recovering from ACL repair used both quads and hamstrings almost equally, whether they peddled with one leg at a time or with both.

“This work helped show that therapists could ‘tune’ the treatment options for individual patients, and use both double- and single-legged pedaling to activate the appropriate muscle groups for a more individualized treatment,” Hutchison says.

The goal is to help someone recover fully, and return to activities as soon as possible,” DesJardins says. “The idea that we can work with recovering athletes and physical therapists to make rehabilitation treatments more effective is great.”
