SCC, District 3 & USC Upstate partner to launch first Teacher Pathway Program in Spartanburg County

City Council approves development agreement for new townhomes

The \$19+ million development will be the third in the city for Lat Purser and Associates, following The Fitzgerald located on Kennedy St. and the Boxcar Apartments project currently under construction on Union St. along the Mary Black Foundation Rail Trail.




