time, want to be nice, to do what is asked and to please those asking for our help. We usually try to be accommodating at work,

with our friends, and with

our family members. But sometimes, rather than replying, "Sure," when asked to do an inconvenient favor, or to take on a task beyond our abilities, it may make better sense to say, "No."

It can often be difficult to just utter that simple "no." We like to look responsible helpful and capable. However, the reality is that saying "yes" to virtually every request can produce a variety of negative results.

Research has shown that the more difficulty someone has in saying "no," the more the person is likely to experience stress, burnout and possibly even depression. Difficult requests are highly likely to make you feel frustrated or anxious, or even mad at yourself for saying yes in the first place.

The key to saying no is to do it in a respectful and courteous manner. It starts with understanding what vour own boundaries are and not being embarrassed to accept and follow those boundaries. When you see that a request is going to push you into a zone where you'll feel uncomfortable or not fully competent, it's important to make your feelings, and decision, clearly known.

Responding to a request with phrases like, "Gee, I'm not certain I can," makes it clear that you are not being straightforward about your decision. That's also true when your immediate response is to start apologizing or making excuses and explanations for why you can't do what's being requested.

Instead, first make sure that saying "no" is really only alternative. Politely let the person know you would like to help, but first ask questions to clarify what is really needed. Perhaps there is a way that you can help that wasn't evident when your aid was initially requested. But if it turns out that no really is the only right answer, then state your decision clearly. Let the person know you're sorry you can't help, but that it just wouldn't work.

While we all want to be helpful, it's important to recognize your own limitations, interests and capabilities. Stepping too far outside those comfort zones will leave you feeling anxious and frustrated, and probably won't be the best help available.





## Riley Institute receives grant to expand study of Montessori education

The Riley Institute at Furman University has been selected to join a research team that will explore how Montessori education can advance the academic and social-emotional development of chil-

Funded by a \$600,000 grant from the Brady Education Foundation, the five-year study involve researchers, sites and participants across the U.S. and will follow a randomized sample of children from age three through kindergarten.

"South Carolina has been a leader establishing Montessori programs in public schools, and the Riley Institute's previous research has shown that children in public Montessori programs show stronger achievement growth and socialemotional outcomes," said Brooke Culclasure, research director for the Riley Institute at Furman. "This holds true across students' socioeconomic. racial and ethnic backgrounds. We are thrilled to collaborate on this second study to explore the potential of Montessori even further."

Montessori education is unique in that it balances child-directed academic content with an equal emphasis on moral, emotional and behavioral development. Teachers carefully design environments which allow children to be relatively free to explore a variety of handson lessons at their own



# Drug and alcohol abuse: A growing problem for those growing old

(StatePoint) Misuse and abuse of drugs and alcohol among the elderly is one of the fastest growing health problems in the U.S., according to the Substance Abuse and Mental Health Services Administration (SAMHSA), yet it can often be mistaken for normal aging behavior.

The statistics are alarming: according to The National Council Alcoholism and Drug Dependence, Inc., 2.5 million older adults have an alcohol or drug problem; while a SAMHSA report shows that the use of illicit drugs, combining drugs with alcohol, and the nonmedical use of pharmaceuticals, results in an average of nearly 300 emergency room visits nationwide each day for those aged 65 and older.

trends, substance abuse among the elderly often goes unrecognized and untreated. According to "The Tough Talk: Aging Parents and Substance Abuse," a new survey commissioned by WellCare Health Plans, Inc., adult children of elderly parents know very little about the drugs and

Despite these disturbing



alcohol their parents consume, and three-quarters say it's possible that they may not even know if their parent had a substance abuse problem, likely mistaking the signs -- such as slurred speech, dozing off and confusion -- for normal behaviors of aging.

"While family members may not feel equipped to identify an abuse problem, they are often the ones who can best spot changes in behaviors that could indicate one exists," said Kevin Middleton, Psy.D., vice president, behavioral health, WellCare. "Given the serious consequences that overuse or abuse of drugs and alcohol can have on seniors, it's important to look for those signs and also ask questions that will help determine if and what kind of help is needed."

Dr. Middleton advises those with aging loves ones to be aware of the following.

• Life Changes Can Trigger Abuse: Retirement, the death of a spouse or dear friend, the loss of a pet and other significant life events, are times when the elderly are most likely to begin misusing or abusing drugs and alcohol.

• Signs of a Potential

Problem: Many older people will hide their problem out of shame, and while substance abuse can mimic symptoms of other diseases, always consider the possibility of abuse if there are any major changes in behaviors, such as loss of interest in hobbies, activities or socializing, as well as changes in appetite and sleeping habits. Other

signs to be aware of are

noticeable memory loss, slurred speech and confusion.

• Asking Questions is the First Step: At times when loved ones appear sober and alert, start asking questions about their use of drugs and alcohol and if they think they have a problem. Speak frankly about your concerns and the risks of substance abuse, but also be sympathetic to the difficulties with which they're dealing.

• Seek Help: If you do suspect a substance abuse problem, contact his or her health care provider and discuss the best approach to getting appropriate treatment.

# Alcohol ignition interlock devices found to drastically decrease fatal crashes

Charlotte, N.C. - Requiring all drunk driving offenders to install alcohol ignition interlock devices (IID) can reduce the number of impaired drivers in fatal crashes by 16 percent, according to a new study conducted by the Insurance Institute for Highway Safety.

Additionally, if every state adopted IID laws, more than 500 more lives could be saved each year. Today, 31 states and the District of Columbia mandate or highly incentivize ignition interlock devices for all offenders – 28 of those states and DC have all-offender IID laws.

"AAA applauds IIHS for highlighting the important role ignition interlock laws play in reducing the number of crashes, injuries and deaths that occur on our nation's roadways," said AAA Carolinas Foundation for Traffic Safety President Tiffany Wright.

Currently, North Carolina enforces IID penalties in certain DUI cases. First time offenders with a BAC of 0.15 or more mandates an ignition interlock restriction for one year. Additionally, second time offenders automatically receive a 3 year ignition interlock restriction while third time offenders require a 7 year interlock restriction (if the license is restored to the offender).

In South Carolina, courts are required to order the installation and monitoring of an interlock device for any driver whose BAC level is .08% or higher when it is a second time offense. The length of time required depends upon the court, but usually a second time DUI results in a two year requirement, the third garners three years and the fourth results in an ignition interlock permanently.

In 2016, there were 375 fatal crashes as a direct result of alcohol in North Carolina, according to the NCDOT and 296 in South Carolina, according to the SCPDS.

Neither of the Carolinas are included in the 28 states with an all-offender IID law, that would immediately require an ignition

interlock system for any driver convicted of a DUI. AAA Carolinas, an affiliate of the American Automobile Association, is a not-for-profit organization that serves more than 2.1 million member and the public with travel, automobile and insurance services while being an advocate for the safety and

Charlotte, N.C. – Carolinians saw a spike at the gas pump over the weekend. North Carolina's average on March 26th was \$2.49, which is eight cents more than a week ago and South Carolina's average was \$2.39 – a double digit increase from its price of \$2.29 last week.

Compared to March 2017, motorists in South Carolina are seeing the biggest difference in gas prices of all states in the region at 38 cents more a gallon. Prior to Hurricane Harvey, the state typically ranked as the cheapest gas prices in the country week after week. "Right now we are seeing the market starting to purge winter-blend gasoline to make room for summer-blend," said Tiffany Wright, AAA Carolinas spokesperson. "The jump in gas prices is just the beginning for the season and we aren't sure how high gas prices might go."

The March 26th national gas price average (\$2.61) is a nickel more expensive on the week, nine cents more than a month ago and 33 cents more expensive than this time last year.

"As Carolinians hit the road for Easter and spring break vacations, they are going to be paying more along the way," said Wright.
