Furman University to hold summer commencement exercises August 13

Greenville - John Beckford, professor of music and former Vice President for Academic Affairs and Dean at Furman University, will serve as speaker when Furman holds its summer commencement exercises Saturday, Aug. 13 at 4 p.m. in McAlister Auditorium.

The university will award approximately 60 undergraduate and graduate degrees during commencement. Furman president Elizabeth Davis will preside over the ceremony.

Beckford, who joined the Furman music faculty in 1976, spent five years as Vice President for Academic Affairs and Dean before retiring at the end of the 2015-16 academic year. He has also served the university as Dean of the Faculty (2008-11) and Chair of the Faculty (2005-07). He will return to full-time teaching at Furman in the spring of 2017 after a fall sabbatical.

Beckford was the first full-time percussion instructor at Furman, and he has been principal percussionist and timpanist for the Quad-City (Iowa/Illinois) Symphony Orchestra and percussionist for the Greenville Symphony Orchestra and Chamber Orchestra. He is also an active freelance musician, having performed with such artists as Henry Mancini, Marvin Hamlisch, Natalie Cole, and the Three Irish Tenors.

In addition to serving for three years as Chair of the Council of Deans for the Associated Colleges of the South, Beckford was a faculty member and chair of the music division with the South Carolina Governor's School for the Arts (1982-1999) and past president of the South Carolina Chapter of the Percussive Arts Society. He holds Bachelor of Music, Master of Fine Arts, and Doctor of Musical Arts degrees from the University of Iowa.

Notice of Abandonment

Spartanburg County Department of Social Services officials report that an infant was brought to Camp Croft Fire Department located in Spartanburg, SC, on August 3, 2016, and placed under the protection of Safe Haven with firefighters. Upon the information and belief of the agency, the child falls under the jurisdiction for "Daniel's Law," the Safe Haven for Abandoned Babies Act.

Baby Doe is an African American female that weighs about six pounds. The baby was reportedly born on August 1, 2016. The infant is now in DSS custody.

Under the Safe Haven Act, a permanency planning hearing will be held at the Spartanburg County Family Court House on September 22, 2016, at 9 a.m.

Any person wishing to assert parental rights regarding the infant must do so at this hearing.

Fitzpatrick takes helm at USC Upstate as interim chancellor

Mary Anne Fitzpatrick, Ph.D., University of South Carolina's vice president for system planning, began serving as the interim chancellor of the University of South Carolina Upstate on Monday, August 1. She replaces Chancellor Thomas F. Moore whose resignation took effect July 30.

"I am honored to be serving as the interim chancellor at USC Upstate and to be entrusted with leading USC Upstate during this transitional time period," said Fitzpatrick. "USC Upstate is of great importance to the state of South Carolina with its special metropolitan mission to serve the Upstate region. For more than a decade, USC Upstate has been ranked as one of the best institutions in the Southeastern United States. I have a great foundation to build upon and tremendous talent to work with—there is an innovative strength and a collaborative spirit evident on our campus. It will be my privilege to guide and nurture that spirit."

Fitzpatrick, an Educational Foundation Distinguished Professor of Psychology, has served as vice president of system planning for nearly a year, responsible for ensuring the improvement of quality, coordination and effectiveness and long-range planning for the statewide system, which has nearly 50,000 students across eight campuses.

In the 10 years leading up to system planning role,

Fitzpatrick served as the dean of USC's College of Arts and Sciences, directing the recruitment of 300 new tenure-track faculty and overseeing efforts to open new centers, institutes and programs and a new School of Earth, Ocean and Environment.

As an associate vice president and vice provost, she spearheaded USC's On Your Time initiative, which reengineered the academic calendar to include a third semester option during the summer that allows students to graduate sooner or pursue co-op, internship and study abroad opportunities.

USC President Harris Pastides, anticipates having a new chancellor in place by the first of the year, said Fitzpatrick is the perfect choice to lead USC Upstate during the transition.

"Dr. Fitzpatrick will make the leadership of USC Upstate her full-time mission during the coming months," Pastides said.

"She will not simply be a caretaker but will build upon USC Upstate's momentum, advance the forward progress and ensure a strong foundation for a permanent chancellor. Her familiarity with the system and the USC Upstate campus, as well as her skills as gifted administrator and higher education leader, will prove invaluable during this time."

USC Upstate offers more than 40 bachelor's degree programs in the liberal arts and sciences, business administration, nursing, and teacher education, and master's degrees in education, informatics, and nursing. Among the fastest-growing universities in South Carolina, USC Upstate is a diverse and dynamic community of 6,000 students from across the Upstate, 36 states, and 15 countries.

Classes begin on Thursday, August 18 where nearly 800 new freshman students will be added to the student enrollment and 25 new full-time faculty members will begin teaching at USC Upstate.

"I look forward to meeting and interacting with students, faculty, staff, and alumni over the next few months as we work together to make USC Upstate an even stronger institution in the next decade," Fitzpatrick, who will address the nearly 400 faculty and staff members at the annual University Day on Wednesday, August 17 at 8 a.m.

Take your stress for a walk in the woods

Yes, today's world is a very hectic place. Our cities and towns are crowded with more people and traffic. Constantly-changing technology is always seeking our attention, and daily living has become more stressful. We are over-stimulated and often overwhelmed.

Most of us have learned to cope with our busy lives, but there is a price we are paying for the almost constant stress we face. We may appear to ignore a lot of the stimulation coming at us each day, but doing so takes almost constant unconscious effort. Studies have found that stressful environments can lead to anxiety and depression, and may also be at least part of the reason for headaches, drinking problems, and various other serious health issues.

So how do we deal with a world that is constantly making demands upon us? The simplest answer, according to many experts, is simply to get away from it all, even if just for a short time. While most of us don't want to move to some remote cabin, experts advise adding just a little nature to our daily lives can make an important difference.

Studies find that even small, simple changes help reduce stress. People who have worked in an office with no windows or just a view of a blank wall, report finding their work environment much more pleasant if they are able to look out and simply see a tree or two.

Something as easy as adding a potted plant or two to the area where you spend a good part of your day can also help reduce daily stress.

The biggest benefit appears to come from actually getting outdoors and into nature. Yes, a walk in the woods really can help soothe you and give you a break from a busy life. But there are also benefits from just taking a lunch time stroll through a nearby park or down a tree-lined street.

This time with nature isn't an opportunity to worry about the day's problems or upcoming issues, but rather a chance to actually listen to the quiet of nature, to admire the beauty of an old tree, or just to smile at those squirrels chasing one another.

No, a walk in the woods is not going to be a miracle cure for all of life's stresses, but it does give your mind a chance to relax and regroup, and that's a positive thing.

Former textile mill once again buzzes with activity

Beaumont Mill is filled with people for the first time in nearly 20 years. After a year of renovations, Spartanburg Regional Healthcare System relocated 600 administrative employees to the former textile mill.

These departments moved from Spartanburg Medical Center and Pinewood Resource Center, located on East Wood Street, to allow more space for patients at the hospital.

Much of the original 18,000 square foot mill was preserved, including the original floors, exterior brick and expansive windows. The mill's long history was incorporated into the renovations with photos and memorabilia displayed throughout the building.

Human resources, employment and recruitment, billing and medical records are among the many services relocated from Spartanburg Medical Center to Beaumont. No physician practices are located in Beaumont.



Spartanburg Regional Healthcare System recently relocated 600 administrative employees to the former textile mill.

The move is part of a 10-year master facility plan, which includes moving the main entrance of Spartanburg Medical Center back to North Church Street and improving way finding in the hospital.

"We need the Spartanburg Medical Center campus to be more user-friendly for our patients and visitors," said Phil Feisal, president of Spartanburg Medical Center. "We recognize that finding your way around the hospital presently can be confusing and somewhat intimidating. We

anticipate that we will gain tremendous efficiencies and be able to further improve patient care with a more streamlined physical plant."

Bill pay and medical informatics offices are now located at Beaumont with office hours from 8:30 a.m. to 5 p.m. Beaumont is accessible from 700 North Pine Street, Spartanburg, 29303. The building's main entrance faces Beaumont Avenue. For further information, call 864-560-MILL.



- Salt and pepper to taste

Instructions:

- Preheat the oven to 375 F. Spray eight cups of a standard muffin tin with nonstick cooking spray.
- Grate the peeled potato. Rinse with cold water and pat dry with paper towels or use a salad spinner. Divide shredded potatoes into prepared muffin cups.

- Drop a tomato into each cup. Sprinkle with salt and pepper and then bake for 5-6 minutes.

- While the potatoes pre-bake, whisk together onions, bell peppers and egg, making sure to lightly beat the eggs. Note: basically any ingredient that works in an omelet will work here!

- Take the muffin tin from the oven, pour the egg mixture into each cup, sprinkle with cheese, and bake for 12-14 more minutes. The eggs will puff up in the oven. When they’re done, the center won’t jiggle.

- Remove from oven. After they cool for a minute, loosen around the edges with a knife and lift from the pan.

- Serve immediately or let them cool completely before wrapping and freezing. Microwave to reheat.



The American Heart Association (AHA) recommends no more than 16 grams of sugar daily for toddlers and a maximum of 32 grams of sugar per day for teens. Many children as young as 1-3-years old already surpass daily recommendations -- typically consuming around 48 grams of sugar daily, according to an AHA study. Older kids consume even more. Pediatric health experts recommend reducing sugar in children's diets.

Some foods that you may not consider "sweet" have more sugar than you may think. A yogurt cup and a granola bar contain about 25 grams of sugar. That's an entire day's worth of sugar in one seemingly nutritious snack. Add a peanut butter and jelly sandwich and a juice box, and your child may have consumed more than 50 grams of sugar before afternoon snack.

What's a parent to do? You don't need to replace your child's favorite food. You don't even need to say goodbye to any individual lunch item. However, you can moderate the total amount of sugar that's being consumed on a daily basis by replacing just one sugary food with a savory one.

With this goal in mind, here are some great ideas for savory swaps.

- Replace yogurt with hummus and carrots.
- Swap out a peanut butter and jelly sandwich for a cheese and mustard sandwich.
- Like the convenience of fruit cups? Replace them with Pearls Olives to Go! in a cup, which are gluten-free, sugar-free black ripe olives that are convenient because they have no messy liquid.
- Replace a juice box with water and a twist of lemon.
- Instead of a granola bar, add a serving of almonds or walnuts.
- Other savory items to try: hard boiled eggs, cubed cheese, cheese sticks, different varieties of olives, peanut butter and celery, sliced pickles and air-popped popcorn.

- For fun and flavor: Pack a put-together mini pizza kit: small pita, shredded cheese, a tablespoon of sauce and a Pearls Olives to Go! cup of sliced or

- For dessert, swap out cookies for some blueberries or strawberries. Sugars in whole fruit enter the bloodstream slowly, and

don't cause the same spikes in blood sugar as does junk food.
