Big South Conference delays fall seasons; targets spring

Charlotte, N.C. – With the health and well-being of its student-athletes as its top priority, the Big South Conference announced on August 12 that it is delaying its fall sports seasons with the intent of playing in the spring. This includes the sports of men's and women's cross country, football, men's and women's soccer, and volleyball. Additionally, fall competitions in the sports of men's and women's golf and men's and women's tennis, and out of season competitions in spring sports have been suspended as well. Football members will be allowed to participate in up to four non-conference games in the fall due to contractual obligations.

Big South member institutions may continue with permissible athletics activities, as defined by NCAA regulations and with the exception of fall sport competition, at their own discretion and in accordance with applicable local and state regulations and procedures.

Logan Pace and Upstate women's soccer spend their summer giving back

After organizing and executing a successful food drive earlier this summer that yielded over 380 pounds of canned goods to local food banks, the USC Upstate women's soccer team continued to reach out and serve in their local communities.

Recently USC Upstate junior goalkeeper Logan Pace (Belmont, N.C.) has working Elevation Outreach and their annual "Love Week" events. The church's annual love week reaches local communities from the United Southeastern States, all the way across the northern border to Toronto, Canada.

"If you know Logan, you know that she wears her heart on her sleeve and she has such a passion for people," USC Upstate Associate A.D. for Student-Athlete Enrichment and SWA Sarah Gildersleeve said. "Having the opportunity to hear her stories all summer then getting the opportunity to see her in action and serve alongside her last week at Love Week has been so inspiring."

Pace is very passionate about her volunteer work and the reach Elevation Outreach has had on her local community. "Serving with the people I love for the community I love has been the best experience of my

life," Pace said. Through the help and organization of Pace, the women's soccer team has driven the 74 miles to Charlotte from Spartanburg to volunteer alongside their fellow teammate.

For Pace, however, this is not the first week she has volunteered this summer. In fact, the Tar Heel State native has volunteered every day since April 17 and has accumulated over 400 hours of service. A few places that Pace has worked this summer include local food drives in both Charlotte and Winston-Salem, the Dream Center (Charlotte, N.C.), Nation Elementary School (Charlotte, N.C.) and the Second Harvest Food Bank (Winston-Salem, N.C.).

Through Elevation Outreach, Pace also volunteered her time in Talladega, Ala. with the Convoy of Hope and the Joey Logano foundation. The Convoy of Hope, founded in 1994, is a nonprofit organization that focuses on feeding the world through children's feeding initiatives, community outreaches, and disaster response. The Joey Logano Foundation invests in organizations offering second chances to children and young adults during times of crisis and works to inspire others to live a life of generosity.

The junior also volunteered her time with the nonprofit pharmacy Med-Assist, which helps primary low-income patients with medical and medication bills. One of the final places that Pace worked was at the A21 Foundation, a non-profit organization that is working to end human trafficking across the globe.

"Getting to know so many people and hearing so many amazing stories has affected me on a deep level," Pace replied. "I can't wait to take all of that back to the soccer field and to my teammates. I have learned that right outside of USC Upstate people need help. I took heart to seeing each person intentionally."

1/2 cup soy sauce

Worcestershire sauce

1 tablespoon black pepper 2 tablespoons Dijon mustard 1 tablespoon onion powder

1/4 teaspoon red pepper

1. Place the steaks in a shallow baking dish. Using a medium-sized bowl, stir together the oil, soy sauce, vinegar, lemon juice, Worcestershire sauce, pepper, mustard, onion powder, garlic powder, paprika and red pepper flakes until well-

combined.

2. Pour all but about a 1/4 cup of the marinade over the steaks. Reserve the marinade in the bowl for later use and set it aside. Turn the steaks in the pan to coat on both sides. Cover the dish with plastic wrap. Let the steaks marinate at room temperature for 10 min-

3. Heat the grill to mediumhigh heat. Oil the grill grate with a paper-towel dipped in vegetable oil to clean the grill and keep the steaks from sticking. Remove steaks from dish. Aggressively sprinkle both sides of the steak with salt to create a flavorful crust.

4. Place steaks on the cooler part of the grill, over medium heat. Cook steaks for 4 to 5 minutes on each side, brushing steaks often with the reserved marinade.

5. After the steaks have cooked on both sides, remove them from the heat and cover with a piece of foil to keep them warm. The steaks will stay warm and continue to cook. Allow the steaks to rest for 5 minutes before slicing to retain the juices and keep it tender and moist. Serve immedi-

S.C. Technical College System building a workforce

People, and the strength of the workforce they make up, are at the core of economic development. And in South Carolina, it's hard to talk "workforce" without the SC Technical College System, a network of 16 technical colleges across the state that is nationally recognized for programs such as readySC Apprenticeship and Carolina.

Whether it's readySC helping to train employees at new industries or Apprenticeship CarolinaTM offering "earn while you learn" opportunities, these programs and the Upstate institutions Greenville Technical College, Spar-Community tanburg College, Tri-County Technical College and Piedmont Technical College are key to supporting Upstate employer's needs.

And, as the economy rebounds from the disruption of the COVID-19 pandemic with 12.5% stateunemployment reported for May 2020, these institutions are resources for those displaced from restaurant, retail and other service industry jobs, unlocking opportunities to up their skills and wages.

During a May 27 Coffee (Tele)Conversation webinar, system president Dr. Tim Hardee spoke about how the system supports employers, its response to COVID-19, and what's on the horizon.

The SC Technical **College System**

The system serves an average of 100,000 creditseeking and 60,000 continuing education students statewide, keeping price points as affordable as possible, with locations ready to serve all South Carolinians within a 30-minute

Courses and programs are geared toward jobs that exist in South Carolina, as demonstrated by the fact that 90% of system grads are placed in their field of study within a year of graduation.





state, and a range of companies from Michelin to BMW and Boeing - and many smaller companies have benefited from it.

For employers implementing readySC training, such as Volvo and Mercedes-Benz Vans, programs were paused during the early stages of the pandemic. Now, with added PPE, social distancing, and handwashing, the program is back up and running.

For companies who pivoted to respond to critical need items - introducing new processes as a result of modified operations, the Ezone program offers helps to offset training costs.

The E-Zone program offers financial support for incumbent worker training on new technology or processes, offering up to 66% in savings on training costs. The program has been activated by a number of businesses who adapted their production to meet critical item demands in response to COVID-19. On any given day,

readySC is working with approximately 115 projects across the state. Last year, they recruited and trained just over 5,000 people for jobs in the state. EZone is a System program that offers an incentive to companies for training incumbent workers. Last year, 78 companies across the state took advantage of this program with nearly 30,000 South Carolinians eligible for

retraining. "We certainly have had a lot of those companies who have gotten involved in producing masks, PPE hand sanitizer," Hardee said.

The 16 colleges transi-

tioned quickly to online course delivery, using the existing system that previously allowed one-third of courses to be offered online.

One hurdle the system overcame: working with the Governor's Office and the State Board of Nursing to enable 1,100 nurses to complete their clinical coursework using online simulations, so that they could graduate and enter the workforce.

Apprenticeship Carolina Fosters On-the-Job Learning

Another growing success for the system: the Apprenticeship CarolinaTM program, which offers consultation companies services in launching federally-qualified apprenticeship programs.

"It's nice to be viewed as the place that other states come to see how we do it. Our apprenticeship program has grown extensively over the last 12-15 years. And, we have started to delve even more into Apprenticeship Programs," Hardee said.

The system has served 34,000+ apprentices with more than 1,067 registered programs, and another 235 youth apprenticeships have

been established. The program's core components include a jobrelated education, supervised on-the-job learning, and a scalable wage progression. And, the average tenure among employees who have completed apprenticeships is 3.6 years longer than those who have not.

More than 1,000 occupations can be part of the including: program, advanced manufacturing,

construction technologies, healthcare, information technology, tourism & service industries, transportation & logistics, and energy & utilities.

Employers can take advantage of a \$1,000 per apprentice per year for up to four years.

Overcoming **Workforce Shortages** with SC WINS, ManuFirst and **Statewide Marketing**

apprenticeships aren't the only way the system is engaging the emerging talent pipeline.

Last year, nearly 11,000 students took advantage of

the new SC WINS (the Workforce Carolina Industry Needs Scholarship) scholarship program, which supplements Lottery Tuition Assistance and additional scholarships to increase enrollment in programs that train

Six areas were identified: Advanced Manufacturing, IT Healthcare, Technology, Computer Construction, Hospitality and Tourism, and Transportation, Distribution and Logistics.

for high-demand fields.

Another program with room to grow: ManuFirst, a certificate program designed to meet Volvo's hiring needs of 4,000 people by offering a 62-hour training course on teamwork, safety and OHSA requirements that the carmaker used in lieu of required one-year of manufacturing experience.

"I would see us expanding that quite a bit across the state in the coming year," Hardee said.

And, there's a new \$1.5 million, 3-year statewide marketing initiative, I DEFY, in the works geared toward igniting interest in manufacturing among rising high-school seniors.

Developing Future Talent

With such rapid change in the economy - and education delivery - in the first half of 2020, how does the system's fall look?

"Historically, when unemployment goes up, we have more students," Hardee said, "when we have lower than 3% unemployment, enrollment goes down."

Hardee acknowledged that some jobs lost in tourism and hospitality may not return quickly, though openings in healthcare and manufacturing may offer different opportunities.

The system anticipates a return to in-person instruction – especially in fields that require hands-on learning - though with modifications that allow for physical distancing.

"We're encouraged that the fall semester is going to be a good one for the system, but what that number is, I can't really tell you now."

Tips to help erase bullying this back-to-school season

(StatePoint) This backto-school season may look a little different, but no matter what learning environment kids find themselves in this fall, bullving is a real cause for concern.

One in five kids aged 12 to 18 has encountered bullying, according to StopBullying.gov. It can happen in person, online or even by text. • The presence of digital devices and broad reach of social media means more avenues for bullies to reach their targets. Maintain an open dialogue with your child regarding online activity, and don't be shy about keeping an eye on profiles and posts.

• Being the target of bul-

lying can feel isolating and overwhelming. If your child witnesses bullying, encourage them to be an "upstander," not just a bystander. This involves being an ally who stands up to bullies, and it can be as simple as seeking help from an adult, or as ambitious as starting an antibullying program

• It can be disheartening to learn that your own child has engaged in bullying. Remember, bullying is a behavior, and behaviors can be changed.
