County of Spartanburg road construction expect delays

A new roundabout in Spartanburg County is about to begin construction. S and S Construction of Anderson is overseeing construction activities. Expect delays with one-way flagging operation and reduced speed limits. SCDOT is widening SC 11 at the intersection of Parris Bridge Road with a new roundabout road section. Cowpens awarded grant for public improvement project

Columbia - Fifteen communities across South Carolina are slated to benefit from public improvement projects supported by more than \$6.4 million in funds from the latest round of Community Development Block Grant (CDBG) funding.

The Town of Cowpens received \$521,000 for South Main Streetscape improvements.

S.C. Commerce awards CDBG funds in the fall and the spring of each year. Selected through a statewide competitive process, local governments receiving CDBG funds are required to provide at least a 10% match in funding to complete the projects.

Spartanburg Collective slashes prices of local art by 50%

On any given day, Artists Collective | Spartanburg has hundreds of locally made works of art in its three-story building, everything from inexpensive handmade bookmarks to award-winning sculptures worth thousands of dollars -- nearly all of it for sale. But COVID-19 has changed the making and selling of art. People are sheltering in place, not going to galleries, not buying art. Artists, too, are sheltering in place, making more art than normal. As a result there's a glut in the market, and the Collective has more art than it has room for.

To stimulate sales and make way for new art, the Collective will have an "Art Warehouse Sale" in February 2021. Patrons can expect to see select items marked down by as much as 50 percent in Galleries II and III on the main floor. (They can also see the exhibition The Art of Survival, a collective of art that was created during the pandemic by various artists. It is being held over through the end of February in the Solomon

The sale will start Tuesday, Feb. 2, and will continue through Saturday, Feb. 27. The work can be seen Tuesday through Saturday, 10 a.m. until 4 p.m. There is no entrance fee, however, everyone must abide by safety guidelines set forth to stop the COVID pandemic, including the use of facemasks and staying socially distant from each other.

Mediterranean Diet stands the test of time

The Mediterranean diet is in the news again, not only because it's the start of a new vear, but also because it was named as one of the most popular and healthiest diets by several publications. The origins of the "Mediterranean diet" are lost in time because it's based on the eating habits of the Middle Ages, in which the ancient Roman tradition - on the model of the Greeks identified in bread, wine and oil products a symbol of rural culture and agriculture. These were supplemented by sheep cheese, vegetables (leeks, mallow, lettuce, chicory, mushrooms) and a little meat, and among Romans, a strong preference for fish and seafood.

According to a National Center of Biotechnology Information article, the discovery of the health benefits of the Mediterranean diet is attributed to American scientist Ancel Keys, who researched the correlation between cardiovascular disease and diet for the first

In the 1950s, Keys was struck by a phenomenon, for which he could not, at first, provide a full explanation. The poor population of small towns of southern Italy was, against all predictions, much healthier than the wealthier citizens of New York, many of whom had Italian ancestors who emigrated to the United States. Kevs suggested that this depended on food, and tried to validate his original insight, focusing on foods that made up the diet of these populations.

The modern Mediterranean diet is characterized by the emphasis on plant foods such as grains, vegetables and fruits. Olives, olive oil, nuts, beans, legumes, seeds and herbs/ spices are also part of the Mediterranean eating style. The Mediterranean lifestyle also recognizes the importance of physical activity and social interaction at mealtimes.

Grains should be mostly whole grains and can include whole-wheat breads, wholewheat pasta, oats, brown rice. couscous, quinoa or barley.

Fruits and vegetables can be fresh, frozen or canned. The nutrients are similar between the three forms. Canned vegetables can have more sodium, so rinse before using or buy lower sodium options. Fruits and vegetables can be cooked or eaten raw.

Olives and olive oil are staples of the Mediterranean eating style. Olive oil is the main source of fat and is used in cooking, as salad dressing, as a light drizzle on vegetables or as a dip for bread. Olive oil is higher in heart-healthy unsaturated fats and should replace saturated fats like butter or margarine.

Nuts, beans, legumes and seeds are the main sources of protein, healthy fats and fiber. Common beans include chickpeas (garbanzo beans), cannellini beans, kidney beans, lentils and black beans. Nuts are good as a snack, on a salad or added to other dishes.

Herbs and spices add flavor and aroma to foods. They reduce the need for salt and can be rich in health-promoting antioxidants.

Local composer awarded American Prize

Dr. Nolan Stolz, a composer and music professor at the University of South Carolina Upstate, was awarded Second Place in the American Prize's Ernst Bacon Memorial Award for the Performance of American Music (soloist or composer division) in 2020, with awards mailed to recipients in January 2021. This award was for the recording of Stolz's 25-minute orchestral composition Lincoln Highway Suite from the Orchestral Masters, Vol. 5 album released by Ablaze Records in 2018.

Stolz's orchestral suite was recorded in the Czech Republic by the Brno Philharmonic in 2017, which was funded by ASPIRE, RISE, and artist project grants from the University of South Carolina, USC Upstate, and the Chapman Cultural Center, and by private donations.

The recording has received favorable reviews, with airplay as far

away as New Zealand. Fanfare magazine called it "brilliant piece of Americana. . .a piece of inspiration and skill," the "orchestration is brilliantly managed." and "Stolz clearly has a fine repository of [melodies] in his back pocket." David Katz, the chief judge for the American Prize, said Stolz "evidenced skills in the use of the orchestra, in the ability to create telling emotional states, and in evoking genres and styles virtually instantaneously." Katz described the third movement of the suite, "Prairie View," as "emotionally compelling and heartfelt."

The American Prize's awards for various music disciplines such as compo-

sition, performance, and conducting are highly competitive. First place in the "soloist or composer" division of this award went to Dr. Hyunjung Rachel Chung, a piano professor at Spelman College in Atlanta, for her album of works by all American women composers.





5 tips to protect seniors from financial scams right now

(StatePoint) Social isolation among seniors is not only linked to numerous negative health consequences like depression and cardiovascular disease, but it's also a primary contributing factor in financial exploitation and scams. Estimated to affect one in 10 older adults and cost billions annually, the threat of elder financial fraud is pervasive, and especially so right now.

With seniors more isolated than ever due to the pandemic and stimulus checks being sent to millions of Americans nationwide, ex-perts suggest that seniors and their families be extra vigilant.

"Scammers look for key time periods where money and private financial information are in motion. Not only is IRS fraud one of the most common and successful types of scams that exists, as a general rule, additional money equates to additional fraud," says Ron Long, head of Aging Client Services at Wells

"Scammers are banking on the fact that many seniors are apart from families and friends due to COVID-19. When someone is alone, physically or socially, they often miss out on the added benefit of a second pair of eyes and ears."

Compounding the risks



associated with isolation is the number of seniors who feel their chances of falling victim to a financial scam is unlikely. According to a recent Wells Fargo study conducted by The Harris Poll, 69 percent of all seniors age 60 and above believe they're not likely to be susceptible to a financial scam, despite nearly all seniors (97 percent) acknowledging that older people are very or somewhat susceptible to

becoming a victim. When asked about their peers, the poll found that 47 percent of all seniors knew someone who had already fallen victim to a scam.

"The results indicate what most of us want -- the ability to age relatively unaffected from the realiassociated with aging," says Dr. Marti DeLiema, a gerontologist and consultant for Wells Fargo's Aging Client Services. "The problem is

that when someone doesn't feel they're at risk, they're unlikely to take precau-

Integrated Micro Chromatography Systems awarded \$900,000 grant

 Integrated Micro-Chromatography Systems, Inc. (IMCS), known for their expertise in developing recombinant proteins and enzymes, has been awarded a \$900,000 Small Business Innovation Research (SBIR) Fast-Track grant from the National Institutes of Health (Develop-Chemoenzymatic Strategies, Enzymes, and Kits for Accessible and Affordable Gangliosides).

Under this grant, IMCS expands enzymes, reagents, and methods for animal component-free

manufacturing of various gangliosides. This award funds research into the production of affordable gangliosides and kits that will enable researchers to establish the potential of ganglioside-based diagnostics and therapeutic interventions. The grant will be headed by L. Andrew Lee, Ph.D., cofounder and Chief Scienconjunction with Xi Chen, Ph.D., Professor at the Department of Chemistry, University of California,

Gangliosides are bio-

molecules that contain sugars and a particular type of lipids, ceramides. Analogous to biological antennae in cells, gangliosides are involved in critical roles across multiple biological processes, making them ideal for therapeutic applications. With this research grant, IMCS will provide broader scientific tific Officer of IMCS in community access to affordable reagents and tools to synthesize and modify various gangliosides, thereby enabling researchers to understand how these biomolecules

affect neurological func-

Ronald Schnaar, Ph.D., Professor of Pharmacology at the Johns Hopkins University School of Medicine likened the grant's approach to building Legos. Schnaar, who is not involved in the grant, said that the technology presented features a very flexible system that would allow scientists to use molecular building blocks called glycans, to create a library of various gangliosides that could be used for a wide variety of research applications. "If

you give us the pieces to build the Lego [structure], we can generate the tools to study anything from cell activity to testing potential therapeutics. You can use this to build anything. You can build a mimetic library."

In addition to its portfolio of enzymes, IMCS provides technologies to centers, and contract research organizations to develop next-generation antibody and gene therapy technologies, such as those used to fight the

COVID-19 pandemic. Research reported in

"I've decided," he said, flipping on a light, "to turn this into a dormitory for six. What do you think?"


I paced off the space. "Depends who's going to live here," I said.


