Pandemic aid for foster youth & alumni available from federal sources

Young people between the ages of 14 and 26, who are currently or were previously in foster care, are eligible for emergency Pandemic Relief Funds through the federal Consolidated Appropriations Act. More than \$4.1 million will be available to youth in South Carolina to be distributed by the South Carolina Department of Social Services' (SCDSS) Chafee/ETV Program. The program works to help young people in the successful transition to adulthood.

Currently in South Carolina, there are 3,847 youth potentially eligible for a share of this targeted stimulus support. The potential benefits for eligible youth include funds to assist with basic needs like food, access to technology, and other expenses. The ETV award is also temporarily raised to up to \$12,000 per academic year for higher education. Assistance and resources are also available to help eligible youth get into or maintain a home. These are just some of the benefits.

Soup! It's not just for winter

My favorite comfort meal, no matter what the season, is a vegetable-packed bowl of homemade soup. Soup is a simple, unapologetic dish that is a culinary classic with primitive roots.

Anthropologists who study old pottery and other ancient remnants of our society have discovered that soup may be even older than originally believed. Scientists at Harvard University have found 20,000-year-old pottery that shows evidence of being exposed to fire. No one knows for sure what was heated, but there are many reasons to believe it was the first recipe for a broth cooked up by our human ancestors.

Fast-forward several thousand years, and there is more information available about the one-pot meal called "sop," which referred to a piece of bread eaten in broth. By the 17th century, the word "soup" was being used to describe a pottage, or broth. What we know today is that soup, in all its flavors, has humble beginnings. But plain or fancy, complicated or straightforward, it's an ingenious way to have a complete meal in one bowl

Soup, in its many international versions, is an edible ambassador of its origin. From rich, spicy Mexican soups to light Asian broths, soup is as distinct as the people and the language of the countries from which it comes. If most Americans were asked to say the first word that comes to mind when they hear the word "soup," it would be "chicken" or "beef." This reflects our distinct history and what was available to our ancestors.

The early origins of soup consisted of the boiled carcass of an animal. As the early settlers began to have success agriculturally, vegetables were added to the pot. The slaves of the American south, who had little in the way of meat, harkened back to their African roots and were inventive in making soups and stews with vegetables of all kinds. Gumbo, a word from West African dialects meaning okra, originated this way. The soup consisted of a variety of meats, thickened with okra or file, a powder made from ground sassafras leaves.

My favorite soup recipes showcase seasonal vegetables in a richly flavored broth. Although some soups are cold, most are hot, and whether it's served in fall, winter, spring or summer, soup is a wonderful way to create a simple, satisfying meal.

The beauty of soup is that it can be created from whatever you have on hand.

It's a great way to use leftovers or make the most of a full cup of rice or macaroni, a few carrots or potatoes, or a mixture of greens. It's also an incomparable way to get the most out of meat trimmings or to just be luxurious and cook a chicken for no other reason than to make the best chicken soup ever.

Chris Norfolk wins provost's award for teaching with technology

Chris Norfolk, a senior lecturer in the Department of Chemical and Biomolecular Engineering, is winning the Provost Award For Outstanding Teaching With Technology.

When the pandemic hit, Norfolk made quick use of technology to adapt to social distancing. He created computer and 3D-printed models to help teach his students and keep them on track to graduation.

Robert Jones, executive vice president for academic affairs and provost, said the award is well deserved.

"Dr. Norfolk did an excellent job of using technology to enhance his teaching at a critical time for the University and its students," Jones said. "The high ratings he has received from students and the laudatory remarks from them and his colleagues are a testament to the effectiveness of his efforts. I offer him my deepest congratulations on this award."

For those familiar with Norfolk's teaching, it's just the latest way he has stood out. He has long been known as one of the most dedicated educators in the Department of Chemical and Biomolecular Engineering, said the chair, David Bruce.

"Chris helps students learn chemical engineering concepts after hours and on weekends, he takes class materials to injured students in the hospital and he creates custom educational plans for students with significant handicaps or disabilities," Bruce said. "His care for the 'whole student' is beyond comparison."

Spencer Temples, who has taken three classes with Norfolk and serves as a teaching assistant under him, said the senior lecturer has demonstrated a pattern of helping his students in any way he can.

"As a testament to this, our group emailed him in a panic at the end of last semester on a Sunday afternoon and he met with us via WebEx 10 minutes later," Temples said. "Going above and beyond all expectations has simply become normal operating procedure to him."

Among Norfolk's duties is running the department's learning labs for juniors and seniors.

"We're one of the only labs I know of that is doing labs in-person for everyone who wants to come and do it," he said. "That requires us to be flexible in what we

are doing and how we can keep people safe."

For those who can't attend in person, Norfolk came up with an alternative.

He worked with two students to build 3D, computer-aided design models of lab equipment, similar to those used in industry. Students are able to rotate the interactive models as they learn how to plan experiments.

Norfolk said he will continue using the models in the course, even when the pandemic subsides and students return to the lab.

Among the courses Norfolk teaches is CHE 3190, a course on engineering materials. A major topic in the course is the arrangement of atoms to form crystals and how those arrangements affect material properties.

It can be difficult to visualize, so Norfolk created models that he 3D printed. He started off using his personal 3D printer, but it quickly became clear it was too big of a project to do at home.

Norfolk worked with the Watt Family Innovation Center to complete the printing in its Makerspace.

"I ended up borrowing all of their 3D printers while they were shut down for winter holiday to create approximately 500 individual pieces which I allow students to borrow while they are registered in the class," he said.

When students lose or break a model, Norfolk asks them to replace it. That means students have to learn how to 3D print independently, an added bonus, Norfolk said.

Each model Norfolk has created so far is one color and shows one type of atom. But now he is also creating models of alloys that contain several colors representing different types of atoms, such as when carbon is added to iron to make steel. On that project, he is enlisting the help of Machining and Technical Services in the College of Engineering, Computing and Applied Sciences.

For Norfolk, teaching at Clemson is a way of paying back the University for helping lay a foundation for his life. Clemson is where he received a Bachelor of Science in chemical engineering in 2000 and met his wife, Noelle, who received a Bachelor of Science in graphic communications and now works in real estate in Greenville. The couple now have a 13-yearold daughter, Ava, who is in 8th grade.

After Clemson, Norfolk attended Notre Dame,

where he received a Master of Science and Ph.D., both in chemical engineer-

He worked as a postdoctoral researcher at the U.S. Army Research Laboratory in Maryland before returning to the Upstate, where he worked from 2005-13 as a program director for the South Carolina Research Authority.

He has been teaching at Clemson since 2006, starting as an assistant adjunct professor. Norfolk made the jump to full-time lecturer in 2014. He credited the Office of Teaching Effectiveness and Innovation with helping him improve his teaching.

Norfolk said what he likes best about teaching is the relationships with students and helping them find their directions in life.

"Before I joined the University, I was in the defense industry, and that fit really well for me because my dad was military and his dad was a World War II vet," he said. "I really enjoyed feeling like I was helping and part of something important. I think teaching is the same way. I feel like I'm saving the world by training the best generation of engineers possible."

City of Greenville recently awarded \$20,000 TD Green Space Grant

TD Bank Group (TD) and the Arbor Day Foundation have awarded the City of Greenville a \$20,000 TD Green Space Grant. 

giveaways and educational events. The educational events will include tree planting demonstrations led by the City's arborist, community clean-up activities and informational workshops about the importance of trees and the City's efforts to protect and refurbish Greenville's tree canopy.

The City identified Greater Sullivan and Nicholtown as prime project areas based on three factors. First, an examination of the results from a recent U.S. Forest Service flyover, which revealed that both neighborhoods are suffering from tree canopy loss. Over the past 10 years, more than 20% of Greater Sullivan's and nearly 7% of Nicholtown's tree cover disappeared. Second, both neighborhoods were recently the focus of an extensive street tree inventory. Completed in September 2020, this related to the project.

GIS-based inventory provides a shovel-ready plan that will thoughtfully inform the project's tree planting efforts. Finally, the City has community centers in each neighborhood, which will serve as headquarters for community engagement activities

Reversing tree canopy loss not only strongly aligns with City Council's stated priorities but also with citizens' priorities. Community input received during the recent planning process for GVL2040, the comprehensive plan that will shape Greenville's growth and evolution over the next two decades, prioritized open space and the



5 tips to help protect seniors from financial scams

(StatePoint) Social isolation among seniors is not only linked to numerous negative health consequences like depression and cardiovascular disease, but it's also a primary contributing factor in financial exploitation and scams. Estimated to affect one in 10 older adults and cost billions annually, the threat of elder financial fraud is pervasive, and especially so right now.

With seniors more isolated than ever due to the pandemic and stimulus checks being sent to millions of Americans nationwide, experts suggest that seniors and their families be extra vigilant.

"Scammers look for key time periods where money and private financial information are in motion. Not only is IRS fraud one of the most common and successful types of scams that exists, as a general rule, additional money equates to additional fraud," says Ron Long, head of Aging Client Services at Wells

"Scammers are banking on the fact that many seniors are apart from families and friends due to COVID-19. When someone is alone, physically or socially, they often miss out on



the added benefit of a second pair of eyes and ears."

Compounding the risks associated with isolation is the number of seniors who feel their chances of falling victim to a financial scam is unlikely. According to a recent Wells Fargo study conducted by The Harris Poll, 69 percent of all seniors age 60 and above believe they're not likely to be susceptible to a financial scam, despite nearly all seniors (97 percent) ac-knowledging that older people are very or somewhat susceptible to becoming a victim. When asked about their peers, the poll found that 47 percent of all seniors knew someone who had already fallen victim to a scam.

"The results indicate what most of us want -- the ability to age relatively unaffected from the realities associated with aging," says Dr. Marti DeLiema, a gerontologist and consultant for Wells Fargo's Aging Client Services. "The problem is that when someone doesn't feel they're at risk, they're unlikely to take precau-

To better protect seniors from elder financial fraud and abuse, consider these tips from Wells Fargo:

1. Don't wait for a crisis. Seniors should speak with trustworthy family members about financial plans, as well as consult them when something doesn't feel right.

2. Stay up-to-date. Seniors and families should draft and periodically update legal documents such as wills, healthcare directives and powers of attorney.

3. Automate. Seniors should consider signing up for direct deposit, automatic bill pay and large transaction alerts.

4. Prioritize security. should keep

checks and credit cards locked away, and update passwords when information is compromised. They should also carefully review credit reports, account statements and bills for unusual activity or charges.

5. Be aware. Families can help seniors stay aware of the latest and most common scams, as well as help them identify potential red flags, including:

· Alleged emergency situations involving family members, often grandchildren, requiring immediate payment.

• Lottery winnings requiring upfront cash payment for taxes and other

· Phone calls from alleged government agencies, such as Social Security, threatening arrest or penalties.

Petitioner is informed and believes that the Decedent kept his original Will in a safe deposit box which was emptied by his daughter, Respondent Moira A. Bowman, after his wife's death.

6. Petitioner is informed and believes that Decedent did not intend to revoke or destroy his Will but that the original Will was lost, misplaced, or de-stroyed by a third party without the Decedent's knowledge.

7. Petitioner filed an action for the Probate of the Will previously. Petitioner experienced difficultly serving Moira A. Bowman and Daniel Aldrich. Respondent Rhea Aldrich is the currently serving trustee of the Trust. The Trust was amended on October 13, 2004, a copy of which is attached hereto and made a part hereof as Exhibit D. The Trust, as amended, states that the beneficiaries of the Trust are Rhea Aldrich and Richard Loescher, equally, if they survive Michele A. Loescher and Charles R. Loescher. 9. The Property was deeded to Kenneth R. Aldrich, Patricia A. Aldrich and Michele A. Loescher by deed dated July 3, 1990, a copy of which is attached hereto and made a part hereof as Exhibit E.

10. Michele A. Loescher died on October 21; 2004 and her one-third interest in the Property was deeded to Charles $\ensuremath{\mathsf{R.}}$ Loescher, a copy of which is attached hereto and made a part hereof as Exhibit F.
