### Heaters needed at The Salvation Army

### New virtual tool equips foster parents with essential information

This fall, SCDSS will launch the Child and Adult Information Portal (CAIP), a new online tool to help the state's foster parents quickly access important information about children placed in their care.

The CAIP includes school records and health information and allows SC Foster Parents to log-in to the secure DSS website using a smartphone, tablet, desktop or laptop computer, to instantly view and update information about the children in their care.

The portal is scheduled to go live late fall, with training for users expected to begin soon. The CAIP was created by the SCDSS Division of Technology Services and the USC College of Social Work and Health Information Technology Consortium, and was funded by The Duke Endowment. The project team was informed by interviews and focus groups with SC foster parents, DSS case managers, supervisors, child placing agencies, education stakeholders and many others throughout the state.

### Spartanburg's SteelCore donates \$50,000 PPE to Spartanburg Community College

The Spartanburg Community College Foundation recently accepted a \$50,000 donation of personal protective equipment to the College from Spartanburg-based SteelCore Industrial and Welding Supply.

Brandon Coates, president/CEO of SteelCore, and a 2011 SCC graduate, made the donation to honor the College and the faculty, staff who meant so much to him during his time as an SCC student.

The donation included antibacterial wipes, disposable protective masks and liquid hand sanitizer, all which will be used to continue cleaning SCC classrooms and work spaces as well as keep students, faculty and staff safe during the pandemic.

Founded in 2013 by Brandon Coates and his father, Wayne, SteelCore has grown into the largest single source supplier of metalworking tools, equipment and supplies in the Carolinas.

### United Community Banks, Inc. reports third quarter results

Greenville – United Community Banks, Inc. (NASDAQ:UCBI) (United) recently reported third quarter financial results, including solid year-over-year loan and deposit growth and record operating efficiency. United delivered net income of \$47.6 million and pre-tax pre-provision income of \$81.2 million. Diluted earnings per share of \$0.52 for the quarter represented a decrease of \$0.08 or 13%, from a year ago. This decline is largely due to an increase in credit loss provisioning associated with loan growth and the acquisition of Seaside National Bank & Trust (Seaside) along with net interest margin declines largely driven by declines in market interest rates. Compared to the second quarter, diluted earnings per share were up by \$0.20 or 63%. Excluding merger-related and other charges, diluted operating earnings per share were \$0.55, also down 13% from last year, but up \$0.23 per share or 72% compared to second quarter. United's GAAP return on assets (ROA) was 1.07% and its return on common equity was 10.1% for the quarter. On an operating basis, United's ROA was 1.14% and its return on tangible common equity was 13.5%. On a pre-tax, pre-provision basis, and excluding merger-related and other charges, ROA was 1.93%.

## Spartanburg Community College honors 2020 Wall of Fame inductees

Spartanburg Community College honored four Upstate leaders for distinguished service and contributions to the College at the Wall of Fame induction on Thursday, October 22. Held annually, this year's inductees included: Community service category: James M. Folk, former chair and member of the Spartanburg County Commission for Technical and Community Education; Harold D. McClain, retired SCC vice president of student affairs; Dr. Carol R. McFadden, volunteer at the SCC Cherokee County Campus; and in the SCC administration category: Henry C. Giles, Jr., retired SCC president.

"What makes an organization strong are the people and traditions. SCC's tradition of the Wall of Fame is special because it showcases partnerships of the College, explained Dr. G. Michael Mikota, SCC president. "It's incredible to see all the individuals who have been inducted into the Wall of Fame over the years and the many ways they have touched the college in such profound ways. Each one of these individuals we are celebrating today changed many lives."

The SCC Wall of Fame was created in 1998 by SCC President Dan L. Terhune to honor those who have served the College in an extraordinary manner, making the pathway for those to come even better. Induction nominations are made by currently employed SCC faculty or staff and must meet the following qualifications: individuals must have made significant accomplishments on behalf of the college and either have been a faculty or staff member, or a member of the Spartanburg County Commission for Technical and Community Education, SCC Foundation Board, SCC advisory committee, a retired employee, or a community resident who had a significant impact on the college.

"I have the opportunity today to recognize one of

our commissioners who served the college for 23 years, James Folk," said Henry C. Giles Jr. when introducing the first inductee. Reading from Mr. Folk's nomination Mr. Giles shared, "Throughout his service, Mr. Folk's desire was to foster and develop Spartanburg Community College while providing quality, affordable education for students. Mr. Folk served in various Commission leadership positions and was instrumental in changing the College name from Spartanburg Technical College to Spartanburg Community College. He was an outstanding advocate for students and a champion of affordable and accessible education for all. Jim was always focused on what was best for our service area and how to best prepare students."

Ron Jackson, SCC's vice president of student services, welcomed inductee Harold D. McClain, former SCC vice president of student affairs. "It is with great pleasure and privilege that I introduce Harold McClain, who served SCC and the South Carolina Technical College system for 30 years." McClain was recognized for fostering a culture of diversity, equity and inclusion at the College; developing lasting community partnerships that included work with the South Carolina School for the Deaf and the Blind to make SCC a welcoming place for students with disabilities. In addition, McClain developed the College's first Early College program and was instrumental in development of the Dan L. Terhune Student Services building, which centralized all student services.

Inductee Dr. Carol R. McFadden was introduced by Daryl Smith, executive director of the SCC Cherokee County Campus for extraordinary contributions to promote education and enroll students in the Gaffney and surrounding communities. "Dr. McFadden has been a ded-

icated supporter of SCC since the Cherokee County Campus was established, serving on the Cherokee County Campus Advisory commission for 10 years. She is by far the best recruiter that we have, and it is not uncommon to see her in the hallway talking students to sign up for classes. Dr. McFadden exhibits exemplary leadership as the director of the Neighborhood Ambassadors Program, where she leads 60 volunteers from our community as they mentor students all the way through school. Her heart is tremendous and she has impacted the lives of thousands of people over the years."

Dr. Mikota recognized inductee, Henry C. Giles, SCC's sixth president, stating "Today we've heard about history and legacy and how they are the building blocks and foundation for the future. When you think about that, one name comes to mind in the South Carolina Technical College System and that is Henry Giles." Mikota spoke of Giles' 50-year service to SCC, his legacy of advocacy for students, faculty, staff as well as economic and workforce development opportunities for Spartanburg, Union and Cherokee counties; and his work to develop initiatives advancing access to education including the SCC Downtown Campus and dual enrollment programs such as the Viking Early College and the Spartanburg County Early College High School.

Mikota added, "The true measure of any individual is not necessarily what they did, how much money they earned, but how many lives they touched throughout the history of their service. Henry, you are a true public servant in every sense of the word. On this momentous occasion, your highlight your service, your long legacy, your impact on this college, this community, and our state. Thank you for your career of service."

### Toast pumpkin seeds for nutritious treat

Pumpkins are one of the highpoints of the fall harvest. The fruit originated in Central America. Pumpkins – like cantaloupes, cucumbers and squash – belong to the Cucurbitaceae, or gourd family. Most of the pumpkins that are grown in the United States come from Illinois and become available in October.

Whole pumpkins and the carved pumpkin shell are often used as decorative items. The interior pulp is a nutritious addition to savory and sweet dishes, but don't throw out the seeds! Pumpkin seeds make a tasty snack that's low in calories, high in protein and rich in fiber, as well as vitamins B, E and K, and zinc, iron and magnesium. Pumpkin seeds also contain many beneficial fatty acids and amino acids.

The flat, dark-green pumpkin seeds, or pepitas as they are often called, are covered with a yellow-white husk. Pepitas are a key ingredient in Mexican recipes and are often used in the cuisines of many other cultures.

Pumpkins seeds are a power-packed addition to sauces, soups and salads, and they're a healthy snack. Roasting and adding spices enhances their flavor.

### Toasted Pumpkin Seeds

1 pumpkin (field or sugar), about 2 cups  
 2 tablespoons vegetable oil  
 2 tablespoons salt, plus more for sprinkling  
 Cooking oil spray

1. Cut a fresh, ripe pumpkin in half. Remove the membrane and seeds, and as much pulp as possible. Separate out seeds (leaving some of the pulp on adds to the flavor).

2. Do not rinse the seeds, as they will steam instead of toasting. Pick through the seeds and remove any that are split. Do not place the seeds on a paper towel, as seeds will stick to the paper. Instead, place seeds on a sheet of waxed or parchment paper, or on lightly oiled aluminum foil. Heat oven to 300 F.

5. Spread the vegetable oil on a shallow pan. Sprinkle seeds over oil in single layer. Bake 10 minutes, stir and spray with the cooking oil spray. Bake for another 10 to 15 minutes, stir and spray with the cooking oil spray. Bake for an additional 10 to 15 minutes as needed or until lightly browned, being careful not to burn them.

6. Remove from the oven and sprinkle with salt. The seeds will become crispier as they cool. Shell the seeds, or for more fiber, eat them whole. Store in an airtight container.

**Data Breach Impacts 46,000 Veterans**

A data breach occurred at the Department of Veterans Affairs when thieves attempted to divert medical payment funds at the Financial Services Center away from community health care providers that take care of veterans outside the VA. The minute the techies noticed the breach, they took it offline, of course, and locked it pending a security review.

If that was the whole story, it would eventually be worked out when those providers got replacement payments from the VA. However, while the thieves were roaming around in the computers they also got the personal information of some 46,000 veterans, including Social Security numbers.

As breaches go, this is one of the smaller ones the government has experienced. Remember a few years ago when millions of veterans were compromised? Still, it's unnerving to know your info is out there.

Those affected by the breach, or a next of kin, will have been notified by now (the thieves also went after the personal info of deceased veterans). The VA is offering credit-monitoring services at no cost. Alerts went out by mail to those veterans affected, with instructions on how to protect personal info. (If you did not get an alert mail, you were not in the group that was breached.) If you received an alert letter and you have questions or concerns, contact the FSC Customer Help Desk by email at [VAFSCVeteransSupport@va.gov](mailto:VAFSCVeteransSupport@va.gov).

Unfortunately, in this hotly political climate, false rumors are the order of the day. One political party sent a snarly message to the Committee on Veterans' Affairs claiming that in addition to the 46,000 veterans, another 17,000 providers were affected as well. Not so. Turns out that there were 17,000 total providers who used the computer program, but only 13 were impacted and of those, only six had funds grabbed.

THE HISTORY CHANNEL

- On Nov. 3, 1777, Gen. George Washington is informed that a conspiracy is afoot to discredit him with Congress and have him replaced by Gen. Horatio Gates. Major Gen. Thomas Conway led the effort.
