Robert E. Gregory Jr. to step down as Chair of Apella Health Management Board of Trustees

For the past decade, Robert E. Gregory Jr. has guided Spartanburg Regional Healthcare System through the most transformative period in its nearly 100-year history.

At the end of September, Gregory will step down as Chair of the Apella Health Management Board of Trustees, but the impact of his service will be felt for generations.

"It has truly been an honor to serve my community with an outstanding management team in leading Spartanburg Regional Healthcare System and Apella Health for the past decade," Gregory said. "I am proud of the work my fellow trustees, associates, physicians, volunteers and the leadership team do each day to care for their community. I firmly believe the health system is poised for even greater success in the years ahead."

In 2011, Gregory was elected Chair of the Spartanburg Regional Healthcare System Board of Trustees, serving six years, and later began serving on the newly formed Apella Health Management Board of Trustees, where he most recently completed his fourth year as Chair. Community leader Mary L. Thomas will become the next Chair of the Apella Health board.

Spartanburg Regional Healthcare System CEO Bruce Holstien said leadership Gregory's transformed the health system in strategic, meaningful ways to enable it to better meet its mission today and tomorrow.

"Chairman Gregory's guiding hand will be seen in health care in the Upstate for years to come," Holstien said. "From the growth of the health system to the technology used by our providers and associates, his contributions are evident in the lives of patients we treat each day."

Among his numerous accomplishments, Gregory led the board to update the health system's governance structure in 2016, forming Apella Health Management, a 501(c)3 not-for-profit management company that provides oversight to Spartanburg Regional. This change improved the healthcare system's ability to partner with other community hospitals. In addition, the health system has been perennially ranked as one of the top-performing quality of care systems in S.C. and has for multiple years achieved national top quartile associate and

physician workplace satisfaction.

The system's physical footprint also expanded under Gregory's leadership. During his tenure, Regional Spartanburg made new investments in Pelham Medical Center; built the new Gibbs Cancer Center at Pelham; and acquired Union Medical Center, Ellen Sagar Nursing Home, Cherokee Medical Center and Spartanburg Medical Center - Mary Black Campus. Revenue for the system grew nearly \$1 billion during his tenure as Chair, and the system reinvested more than \$820 million in capital improvements.

With a system of six hospital campuses and more than 100 medical offices, the coordination of patient information is vital. Spartanburg Regional started consolidating six different electronic health record systems under Epic in 2016. Through Epic, Spartanburg Regional patients can visit any doctor or hospital, and if that provider uses Epic, their patient records can be accessed, providing important medication and health condition information.

In business, Gregory's national reputation includes managing large successful companies as a turnaround specialist. He is nationally known as a leading business strategist.

During his career, he served as Legal Assistant to the Chief Justice of South Carolina and then as Group Vice President and General Counsel Spartan Mills. He then served as President of the Lee Company and later as President of VF Corporation, the largest apparel company in the world, for 10 years.

In 1992, he established his own turnaround firm and restructured over a dozen companies, includ-Gitano Inc. and London Fog Corp. Gregory then served as operating partner for 10 years with two multi-million private equity firms. During his career, he served in the corporate boards of nearly 20 companies, including NYSE companies, United Missouri Bank, Promus Hotels, VF Corp., London Fog Corp., Gitano Inc., Frisbee International and Globe Manufacturing.

Gregory, the son of a executive, newspaper graduated from Greenville High and Wofford College. After service as a Lieutenant in the Marine Corps, he graduated from the University of South Carolina School of Law and the Harvard Business

School. Throughout his career, Gregory has given generously of his time, skills and resources to religious and charitable foundations. On the local level, besides his service as Chair of Spartanburg Regional Healthcare System and Apella Health, he has also served as Chair of the Board of Trustees of each of the following charitable organizations: Wofford College, Spartanburg County Foundation and Spartanburg Regional Foundation.

Gregory has received numerous awards for his charitable work, including an honorary degree from Wofford College and the Man of Toleration award from the State of Israel.

Summer salsa

When tomatoes and peppers are ripe and plentiful, folks will wonder what to do with all that produce. Salsa is one good option.

It's a good idea to try out the peppers you plan to use in your salsa by trying half of a hot pepper first, stirring the salsa, letting it sit for a few minutes and tasting for heat. See if the temperature is what you expect and what you prefer. It's easier to adjust the mix of peppers in the salsa to gradually make it a little hotter by adding more peppers than it is to deal with an excessively hot and spicy salsa after it's prepared. If someone finds your salsa a bit too hot for their tastes, you might try serving it with some sour cream or salty chips to help calm that spicy

This recipe for Spicy Fruit Salsa combines hot peppers and juicy summer fruits. It's perfect for a snack or appetizer and is also delicious as a topping for fish, chicken or pork.

The diva's spicy fruit salsa Be sure to wear gloves or wash your hands immediately after handling peppers. Do not touch your face, eyes, nose or mouth. To reduce the heat of the peppers and retain the flavor, cut the peppers open and remove the seeds and the ribs, wash your hands thoroughly and proceed with the recipe.

1 large firm but ripe mango, peeled and cubed

1 large firm but ripe peach, peeled and cubed

2 large firm but ripe tomatoes, cored, seeded and coarsely chopped, or 16 grape or cherry tomatoes, cut into quarters

1 cup diced red onion

1 or 2 fresh jalapenos, stemmed and minced

3 tablespoons fresh lime

1 tablespoon honey

1 1/2 teaspoons chili pow-

1 teaspoon salt

1/3 cup finely chopped cilantro

1. In a large bowl, combine the mango, peaches, tomatoes, onion, jalapenos, lime juice, honey, chili powder and salt. Stir well to combine.

2. Cover and refrigerate for up to 1 hour, to blend the flavors. Just before serving, stir in the cilantro and adjust the seasoning. Serve with baked tortilla or pita chips. Makes about 2 cups.

Variations:

Saucy Joes: Brown 1 pound of lean, ground turkey. Season with 3 tablespoons Worcestershire sauce, 1 teaspoon salt, 1 teaspoon freshly ground black pepper. Combine with 1 cup of salsa. Serve on whole-wheat hamburger buns or in pitas.

Salsa Fish, Chicken or Pork: Top individual portions of grilled, pan-fried or broiled fish, chicken or pork with 2 tablespoons of salsa.

Vinson graduated from Clemson in 1981 with a degree in English. She now lives in Albuquerque, New Mexico, and recently ordered ice cream, including her favorite – Double Cookies and Cream using the new Clemson ice cream online ordering system. Vinson sees the new system as a way to connect with and support the uni-

"This new online ordering system is very easy to use," Vinson said. "As a proud Clemson alumna, I wanted to support the '55 Exchange during this COVID-19 pandemic. Even though I now live almost 2,000 miles away from Clemson, I felt this was a way that I could help Clemson students and faculty."

The online ordering system Vinson refers to was created during the spring semester. This system allows Clemson ice cream to be shipped directly to customers nationwide. Orders can be placed online clemson.edu/icecream. On the webpage, click on the order link just below the banner that goes to the CUMarketplace ordering

Money raised from the sale of ice cream supports the '55 Exchange, the student-run business on campus where Clemson ice cream and other dairy products are sold. Just like many other small businesses, the '55 Exchange has taken a big financial hit from forced closure due to COVID-19. The students are hoping to recoup some of their losses.

"We operate just like any other small business, including paying rent to the university, as well as paying our student and professional staff," said

Amy Grace Funcik, a Clemson Food, Nutrition and Packaging Sciences student from the Isle of Palms. "We entered the shutdown with a strong balance sheet, but with no means to generate sales, our financial strength has been severely impacted, placing the '55 Exchange business future in jeopardy. So, we are looking for members of the Clemson Family to help us promote the launch of our ice cream shipping pro-

The students' goal is to

fill at least 100 orders per month. Johnny said McGregor, professor and '55 Exchange advisor.

"We are currently running at about 50 orders per month so we need to double our number of orders before we can meet our financial goals," McGregor said.

Changes are coming to the ordering system that McGregor said are sure to please.

"These changes include the ability for people to select their favorite flavors," he said. "Right now, we are limited to offering preselected flavors that we ship out the second week of every month."

Five common questions about life insurance

Study finds flaws with driver assistance technology

Charlotte, N.C. – Although it's designed to make you safer on the road, AAA is warning drivers to be cautious when trusting certain vehicle technology. What's called "active driving assistance" is designed to automate certain aspects of driving. However, AAA researchers warn that this system is far from 100% reliable.

Testing the Technology

While there are various forms of Advanced Driver Assistance Technologies in vehicles today, Active Driving Assistance is unique in that it combines functionalities like steering, acceleration and braking. AAA's research focused on five vehicles equipped with Active Driving Assistance.

Test drivers noted that adaptive cruise control performed well. However, through the course of 4,000 miles of driving, the vehicles experienced some other type of issue every 8 miles, on average.

Researchers noted instances of:

- 1. Trouble keeping the vehicles in their lane and coming too close to other vehicles or guardrails
- 2. Systems often disengaging with little notice almost instantly giving control back to the driver

"Active driving assistance systems can give motorists a false sense of security which can sometimes take their attention away from driving," said Tiffany Wright, spokesperson, AAA – The Auto Club Group in the Carolinas. "It's important to remember that these systems aren't consistent and are constantly evolving so it's imperative to remain focused and engaged behind the wheel at all times."

Why the Lane Centering System Struggles

On public roadways, nearly three-quarters (73%) of all system errors involved instances of lane departure or erratic lane position. These systems

currently rely on in-vehicle cameras to determine lane position. Just like our eyes, the cameras struggle to "see" when lane markings are not clear or when the sun is providing too much glare. Also, lane changes can happen suddenly, causing the vehicle to struggle in a more complex driving environment.

Collisions with Disabled Vehicles

While AAA's closed-course testing found that the systems performed mostly as expected. They were particularly challenged when approaching a simulated disabled vehicle, partially in the roadway. When encountering this test scenario, in aggregate, a collision occurred 66% of the time and the average impact speed was 25 mph.

AAA Recommendations

AAA believes manufacturers should do more simclosed-course ulations, testing and actual on-road evaluations prior to releasing to the mass market. These systems need to perform more consistently in order to improve the driver experience and overall reliability and safety. AAA has met with industry leaders to provide insight from the testing experience and shared our recommendations for improvement.

Should Drivers Purchase Vehicles with Active Driving Assistance Systems?

While the adaptive cruise control functionality of the active driving assistance systems works well, lane keeping assistance struggles. Our advice is to look for a vehicle with adaptive cruise control but wait a few years until the technology improves before purchasing a vehicle with active driving assistance.

AAA's 2020 automated vehicle survey found that only one in ten drivers (12%) would trust riding

in a self-driving car. To increase consumer confidence in future automated vehicles, it is important that car manufacturers perfect functionality as much as possible – like active driving assistance systems available now - before deployment in a larger fleet of vehicles. The insights are also shared with AAA members and the public to inform their driving experiences and vehicle purchase decisions.

Methodology

AAA conducted closedcourse testing and naturalistic driving in partnership with the Automobile Club of Southern California's Automotive Research Center and AAA Northern California, Nevada and Utah's GoMentum Proving Grounds. Using a defined set of criteria, AAA selected the following vehicles for testing: 2019 BMW X7 with "Active Driving Assistant Professional", Cadillac CT6 with "Super CruiseTM", 2019 Ford

Edge with "Ford Co-Pilot360TM", 2020 Kia Telluride with "Highway Driving Assist" and 2020 Subaru Outback with "EyeSight®" and were sourced from the manufacturer or directly from dealer inventory. The 2019 Cadillac CT6 and the 2019 Ford Edge were evaluated only within naturalistic environments.


