Senior United States District Judge Henry M. Herlong, Jr., of Greenville accepted the guilty pleas and will impose sentence after he has reviewed the presentence reports which will be prepared by the U.S. Probation Office.

Evidence presented at the change of plea hearing established that Mark Betancourt, Juan Betancourt, and Joseph Sansosti robbed Carolina Cashers on May 23, 2015. That morning, Joseph Sansosti and Juan Betancourt pushed their way into the business. Sansosti then grabbed an employee,

Betancourt. The two men then ran out of the store to the getaway car, which was driven by Mark Betancourt.

Acting United States Attorney Drake stated the maximum penalty for Hobbs Act Robbery and Conspiracy to Commit Hobbs Act Robbery is imprisonment for 20 years and/or a fine of \$250,000.00, and the maxpenalty imum for Brandishing a Firearm in Furtherance of a Crime of Violence is imprisonment for not less than seven (7) years consecutive to any other sentence, up to a maximum of Life.

The case was investigated by agents of the Bureau of Alcohol, Tobacco, Firearms, and Explosives and the Greenville County Sheriff's Office. Assistant United States Attorney Jamie Lea Schoen of the Greenville office is prosecuting the case.
